

Shares of FIDSON, FTNCOCOA & COURTVILLE Top Gainers Chart as NGX All-Share Index Gains by 6bps; NIBOR Rises amid sustained Liquidity Squeeze...


The local equities market All-Share index rebounded up by 0.06% to close at 53,201.38 points as investors were bullish mostly on the shares of FIDSON (+9.59%), FTNCOCOA (+9.09%), COURTVILLE (+8.51%), JAIZBANK (7.78%) and FCMB (+5.16%). On the negative side, shares of MRS, TIP, LEARNAFRICA, OANDO and AIICO led the top bottom losers, leading to their respective prices to fall by 9.76%, 9.09%, 4.00%, 3.23% and 2.0%. Given the bullish sentiment, the year-to-date gain of the index increased further to 24.55% despite the Exchange printing a higher number of losers (17) than gainers (14). Nonetheless, performance across sub-indices tracked was mixed as the NGX Banking index and the NGX Consumer Goods index which rose by 0.05% and 0.02% respectively. The NGX Insurance index and the NGX Oil/Gas index fell 0.50% and 0.46% respectively. The NGX Industrial index remained flat. Elsewhere, Market activity was weak today, as the volume of stocks traded dipped by 14.19% to 273.24 million units; Also, the value of stocks traded decreased by 20.72% to N2.65 billion. Meanwhile, NIBOR rose for all maturities tracked amid sustained financial system liquidity squeeze. Also, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
