

Equity Market Kicks Off the Week with a Decline of 0.16%, as Profit-Taking Dominates; NIBOR Falls amid Renewed Liquidity Ease...


Bears (25) upstage bulls (8) as NGX resumes week's trading negative, after the market had closed positive on Friday following two straight trading sessions of consecutive losses. Hence the NGX-All Share Index moderated by 0.16% to close at 53,113.64 points. Sell pressure on small and medium cap tickers such as CAP (-9.93%), CAVERTON (-7.83%), LIVESTOCK (-6.25%), TRANSCORP (-5.07%) and CHAMPION (-4.63%) led the top 5 bottom losses chart leading to further decline of the year-to-date gain of the index to 24.34%. Similarly, performance across sub-indices tracked was negative, except for the NGX Insurance index which rose by 0.16% - largely due to 5.00% gain on WAPIC shares. The NGX Banking index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index fell by 0.35%, 0.01%, 0.46% and 0.11% respectively. Elsewhere, Market activity was strong today, as the volume of stocks traded rose by 9.79% to 299.99 million units; Also, the value of stocks traded increased by 17.11% to N3.01 billion. Meanwhile, NIBOR fell for most maturities tracked amid renewed financial system liquidity ease. However, NITTY rose for all maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds fell for most maturities tracked amid renewed bearish sentiment. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
