

Equities Market sustains losing streak amid Losses in Bellwether Shares; NIBOR Falls for Most Tenor Buckets Tracked on Financial System Liquidity Ease...

Equities trading at the Nigerian Exchange Limited (NGX) closed bearish (-1.97%), extending the negative trend as the industrial sector shares led today's decline. Accordingly, the year-to-date performance of the index crossed below 20%, for the first time since May 6th to 18.82%, even as the Exchange printed a higher number of losers (31) than gainers (7). JAIZBANK topped gainers growing by 5.32% while DANGCEM led the laggards chart declining by 10.00%. Specifically, we saw price depreciation in medium and large capitalized stocks such as INTBREW (-9.60%), FLOURMILL (-8.57%), FBNH (-7.22%), and UNILEVER (-1.33%). Amid sustained bearish mood, four of the five sub-sector indices tracked closed red, especially the NGX Industrial index which fell by 5.27%. Also, the NGX Insurance index, NGX Consumer Goods index and the NGX Oil/Gas index decreased by 0.94%, 1.16% and 0.23% respectively. The NGX Banking index closed in green by 0.35%. Elsewhere, Market activity was mixed today, as the volume of stocks traded rose by 43.04% to 345.00 million units; While, the value of stocks traded decreased by 16.15% to N3.07 billion. Meanwhile, NIBOR fell for most maturities tracked amid renewed financial system liquidity ease. However, NITTY rose for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid bullish sentiment.
