

DANGCEM, TRANSCORP, SEPLAT, Spur Stock Market to End Bearish Streak; NITTY Rises for All Tenor Buckets amid Sustained Sell Pressure...

The local bourse All-Share index rebounded by 0.66% to close at 51,091.75 points. Hence, the year-to-date gain of the index rose to 19.61 % despite the Exchange printing a higher number of losers (22) than gainers (14). Notably, LIVESTOCK gained 10.00% to lead the best five performing stocks at close of trading today. Also, MRS (+9.80%), DANGCEM (+8.30%), NAHCO (+7.69%) and ROYALEX (+5.56%) closed positive while BUAFOODS (-10.00%), GLAXOSMITH (-9.22%), FBNH (-6.67%) and MTNN (-0.90%) closed negative. Amid the bullish mood, three of the five sub-sector indices tracked closed green, especially the NGX Industrial index which rose by 3.96% - largely due to the appreciation of DANGCEM's share price. Also, the NGX Banking index and the NGX Oil/Gas index increased by 0.38% and 0.68% respectively. The NGX Insurance index and the NGX Consumer Goods index closed in red by 0.06% and 0.11% respectively. Elsewhere, Market activity was weak today, as the volume of stocks traded fell by 51.60% to 166.97 million units; While, the value of stocks traded decreased by 10.86% to N2.74 billion. Meanwhile, NIBOR moved in mixed directions. ease. However, NITTY rose for all maturities tracked on sustained sell pressure. In the OTC bonds market, the values of the FGN bonds gained for all maturities tracked amid renewed bullish sentiment. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid persistent buy pressure.
