NGX-ASI Rises by 47 bps amid Gains on FBNH, UBN, MTNN Shares; NIBOR Rises for All Tenor Buckets Tracked on Renewed Liquidity Strain...

The NGX All Share-Index rose by 0.47% to close at 51,618.73 points despite the Exchange printing a higher number of losers (22) than gainers (18). FBNH gained 9.78% to lead the best five performing stocks in the session. Hence year to date gain of the local bourse rose to 20.84%. Also, we saw buying interest in Tickers such as UBN, MTNN, OANDO and ETI leading to 6.19%, 3.85%, 3.51% and 2.11% increase in their respective share prices. Performance across sub-sector gauges was largely positive except for the NGX Consumer Goods index which fell by 0.34%. The NGX Banking index, NGX Insurance index, NGX Oil/Gas index and the NGX Industrial index rose by 0.15%, 0.73%, 0.53% and 0.01% respectively Elsewhere, Market activity was weak today, as the volume of stocks traded fell by2.67% to 223.25 million units; Similarly, the value of stocks traded decreased by 10.57% to N2.86 billion. Meanwhile, NIBOR rose for all tenor buckets tracked as liquidity dried up. However, NITTY fell for all maturities tracked on renewed buy interest. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained sell pressure.
