NGX-ASI Rises by 3bps amid Gains on UPL, UBN, FBNH Shares; NIBOR Rose for most Tenor Buckets Tracked amid Financial System Liquidity Strain...


The NGX All Share-Index rose by 0.03% to close at 51,817.59 points even as the Exchange printed a higher number of gainers (20) than losers (18). UPL gained 9.79% to lead the best five performing stocks in the session; Also, we saw buying interest in Tickers such as FCMB, CHAMS, UBN, FBNH, FLOURMILL and SEPLAT, leading to 4.85%, 4.35%, 4.24%, 1.75%, 1.56% and 0.78% increase in their respective share prices. Given the northward movement in the benchmark index, performance across sub-indices was largely positive except for the NGX Consumer Goods index and the NGX Industrial index which fell by 0.21% and 0.15% respectively. The NGX Banking index, NGX Insurance index, and the NGX Oil/Gas index rose by 0.28%, 0.41% and 0.42% respectively. Elsewhere, Market activity was mixed bag today, as the volume of stocks traded dipped by 46.43% to 223.11 million units; While, the value of stocks traded increased by 12.01% to N3.87 billion. Meanwhile, NIBOR rose for most tenor buckets tracked as liquidity dried up. Elsewhere, NITTY also rose for all most maturities tracked amid sell pressure. In the OTC bonds market, the values of the FGN bonds fell for most maturities tracked amid bearish sentiment. Also, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell Interest.
