

Local Equities Market Index Rebounds Marginally by 1bps amid Renewed Bargain Hunting; NIBOR Rises for Most Tenor Buckets on Sustained Liquidity Crunch...

The domestic stock market index rebounded marginally by 0.01% to settle at 51,563.73 points amid renewed bargain hunting activities; even as the Exchange printed a higher number of gainers (15) than losers (10). Hence, the year-to-date gain of the NGX ASI rose to 20.71%. Specifically, mid and large cap stocks such as ACADEMY, NAHCO, HONEYFLOUR, JAIZBANK, TRANSCORP and GTCO rose by 9.55%, 9.41% 8.39%, 3.70%, 2.40% and 0.49% respectively. Sectorial performance was mixed bag today– the NGX Banking and the NGX Consumer Goods rose by 0.50% and 0.12% respectively, while the NGX Insurance index fell by 0.11%. The NGX Oil/Gas index and the NGX Industrial index remained unchanged. Elsewhere, Market activity was strong today, as the volume of stocks traded grew by 5.94% to 143.29 million units; While, the value of stocks traded increased by 22.07% to N1.76 billion. Meanwhile, NIBOR rose for most tenor buckets tracked as liquidity dried up in the financial system. Elsewhere, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bearish sentiment.
