
The Bears Ruled the NGX as Investors Lost N28.05 Billion; NIBOR Stayed Muted for Most Tenor Buckets on Liquidity Ease...

The bears ruled the local bourse for the third straight day on Thursday with waning investor sentiments and driving the benchmark index southward by 0.10% to close at 51,339.01 points as market continued trading at a tight range. Consequently, the year-to-date gain of the index dropped slightly to 20.19% despite the Exchange printing a higher number of gainers (14) than losers (12). Explicitly, we saw positive sentiment on symbols such as ACADEMY (+9.66%), REGALINS (+8.00%), CWG (+7.95%), CUTIX (+7.27%) and NAHCO (+5.00%) leading to price gains. However, CHAMPION led the chart of decliners and closing at -8.74%. Trailing, were IKEJAHOTEL (-7.69%), INTERBREW (-5.17%) MULTIVERSE (-4.76%) and UPDC (-2.50%) in that order. Across the sectorial front, performance remained mixed as the NGX Insurance gained (+0.58%) while the NGX Oil/Gas closed flat. Meanwhile, the NGX Banking, NGX Industrial and Consumer Goods indices fell by -0.02% and -0.02% and -0.93% respectively. Further afield, market activity was downbeat today as the volume and value of traded equities fell by 41.9% and 44.72% to 115.41 million units valued at N1.21 billion. Elsewhere, NIBOR rate stayed muted for most tenor buckets tracked amid ease in system liquidity while the NITTY rose for most maturities tracked due to buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged from last close; while the values of FGN Eurobond tanked across all maturities tracked on renewed bullish sentiment.
