


SEPLAT, GTCO, UCAP, and Others Extend Positive Sentiment, as Investors Gain N57 Billion; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

The NGX All Share Index inched up 1.71% to close at 52,215.12 points, increasing the weekly gain to 1.28%, even as the year-to-date gain climbed to 22.24%. The Exchange At the end of Monday's trading, the local bourse index advanced by 20bps to close at 52,319.41 points as investors picked up shares of SEPLAT (+10.00), FLOURMILL (+2.41), GTCO (+1.91), UCAP (+1.58) and MANSARD (+1.52). Hence, the year-to-date gain of the NGX ASI rose to 22.48% albeit; the number of losers (22) outweighed that of the gainers (16). Despite the bullish sentiment, Performance across sub-sector gauges was largely negative - the NGX Banking Index, NGX Insurance Index and the NGX Consumer Goods Index fell by 0.04%, 0.53% and 0.64% respectively, while the NGX Oil/Gas Index rose by 4.02%. The NGX Industrial Index remained unchanged. Nevertheless, Market activity was weak today, as the volume of stocks traded fell by 38.83% to 116.28 million units; Also, the value of stocks traded decreased by 16.09% to N3.46 billion. Meanwhile, NIBOR fell for most tenor buckets tracked amid financial system liquidity ease. Elsewhere, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bullish sentiment.
