Gains in Banking Sector Spur Stock Market to End Bearish Trend, as NGX ASI Rises by 1.42%; NITTY Falls for all Tenor Buckets amid Buy Pressure...

Equities trading at the Nigerian Exchange Limited (NGX) closed bullish, amid improved investors demand for bank shares. Accordingly, the year-to-date performance of the index increased to 17.92%, even as the Exchange printed a higher number of gainers (25) than losers (13). UBN topped gainers growing by 10.00% while MTNN led the laggards chart declining by 6.99%. Specifically, Big lenders FIDELITYBK (+9.66%), ZENITHBANK (+9.52%), UBA (5.88), ACCESSCORP (+5.88) and GTCO (-5.03%) led the upturn among banking stocks. Sectorial performance was strong as all of the five indices tracked closed in green territory; – the NGX Banking Indices, NGX Insurance Indices, NGX Consumer Goods Indices, NGX Oil/Gas Indices and the NGX Industrial Indices rose by 6.60%, 0.91%, 0.20%, 0.06% and 0.24% respectively. Market activity mixed bag, as the volume of stocks traded rose by 23.55% to 254.77 million units; While, the value of stocks traded decreased by 28.29% to N2.81 billion. Meanwhile, NIBOR was flattish for all maturities tracked. Elsewhere, NITTY fell for all maturities tracked amid sustained bullish sentiment. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy interest.


