Price Depreciation In BUACEMENT, INTBREW, UACN Stocks, Pull Equity Market to Recede by 83bps; NIBOR Falls for all Tenor Buckets on Liquidity Ease...


The domestic bourse index moderated by 0.83% to settle at 49,950.32 points, as investors continue to digest a wave of half-year corporate earnings; hence, the year-to-date gain of the local bourse fell to 16.94%. Despite the negative sentiment in the market, the number of gainers (21) outnumbered that of the losers (14). Specifically, tickers such as BUACEMENT, INTBREW, UACN, ACCESSCORP and FBNH suffered losses as their respective share prices moderated by 9.96%, 6.54%, 5.71%, 1.11% and 0.45%. Sectorial performance was mixed. The NGX Banking Indices and the NGX Insurance Indices rose by 0.19% and 0.12% respectively; while the NGX Consumer Goods Indices and the NGX Industrial Indices fell by 0.13% and 4.18% respectively. The NGX Oil/Gas Indices remained unchanged. Market activity was weak, as the volume of stocks traded rose by 30.90% to 176.05 million units; While, the value of stocks traded decreased by 19.21% to N2.27 billion. Meanwhile, NIBOR fell for all maturities tracked amid financial system liquid ease. Elsewhere, NITTY rose for all maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained flat for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy interest.
