Consumer Goods and Banking Sectors Lift Stock Market to Advance by 1.35%; NIBOR Falls for all Tenor Buckets on Sustained Liquidity Ease...


The domestic equities market All Share Index (ASI) rose by 1.35% amid renewed bargain hunting activity, especially on Consumer goods stocks such as HONEYFLOUR (+9.66%), NESTLE (+2.99%), UNILEVER (+2.74%) and INTBREW (+2.00%). Tier-1 banking stocks, ZENITHBANK and GTCO, also, Telecommunications heavyweight MTNN saw appreciation of their share prices by 1.90%, 1.75% and 7.45% respectively. Given the bullish mood, the Exchange printed higher number of gainers (19) than losers (9), the year-to-date gain of the NGX ASI rose to 18.52%. Sectorial performance was strong as the NGX Banking Indices, NGX Consumer Goods Indices and the NGX Industrial Indices rose by 0.63%, 1.14% and 0.02% respectively; while the NGX Insurance Indices fell by 0.04%. The NGX Oil/Gas Indices remained unchanged. Market activity was mixed, as the volume of stocks traded dipped by 26.63% to 129.17 million units; While, the value of stocks traded increased by 25.99% to N2.86 billion. Meanwhile, NIBOR fell for all maturities tracked amid sustained financial system liquid ease. Elsewhere, NITTY fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds remained flat for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sell interest.
