Banking Sector Sends Local Bourse Southward as NGX-ASI shed 0.12%; NIBOR Rises for Most Maturities Tracked on Liquidity Squeeze...


The local bourse ASI moderated by 0.12% to close at 50,014.60 points as negative sentiment returned. As a result, the NGX ASI's year-to-date gain declined to 17.09%. The Exchange printed more gainers (21) than losers (15) as investors hunted for bargains given the lower re-entry prices for most stocks. However, bellwethers including UBA, ACCESSCORP, MTNN and ZENITHBANK restrained the market's positive action. Their respective stock values depreciated by 2.78%, 1.12%, 0.50% and 0.23%, respectively. Performance varied within the tracked sub-sector gauges; the NGX Banking index and Consumer Goods index both experienced declines of 0.62% and 0.03% respectively; while the NGX Insurance Index and NGX Industrial index both increased by 0.61% and 0.10% respectively. The NGX Oil/Gas index ended unchanged. Meanwhile, trading activity was uneven as the volume of stocks exchanged fell by 52.70% to 133.59 million units, while the total value of stocks traded increased by 17.06% to N2.44 billion. Elsewhere, NIBOR jumped across the board for most tenor buckets as liquidity in the financial system tightened.; similarly, NITTY rose across the board for the majority of maturities tracked amid sell pressure. Further afield, in the bond market, the values of FGN bonds in the OTC bond market remained stable for the majority of maturities tracked, whilst the values of FGN Eurobonds increased amid purchasing demand for all tracked maturities.
