## Consumer Goods Sector Sustains Negative Sentiment, As Local Bourse Recedes By 7bps; NIBOR Rises for all Tenor Buckets on Liquidity Squeeze...


The NGX All Share Index (ASI) fell 0.07% to 49,629.43 points at the close of trade, with 17 losers outnumbering 12 gainers. As a result, the NGX ASI's year-to-date gain has decreased to 16.18%. The market mood was negative as investors responded to the NBS's high inflation rate reading for the month of July. The consumer goods sector (-0.33%) took the largest blow, as investors speculated on how high prices and rising borrowing costs would impact consumer spending and corporate profits. Hence, Tickers such as PRESCO, DANGSUGAR, FTNCOCOA, ACCESSCORP, FBNH, INTBREW and GTCO depreciated by 9.97%, 4.19%, 3.13%, 2.84%, 2.27%, 1.96% and 0.25% respectively. Sectorial performance was positive, with three of the five indexes closing higher, with the exception of the NGX Consumer Goods index, which fell by 0.33% and the NGX Insurance index which was unchanged. The NGX Banking index, the NGX Oil/Gas index, and the NGX Industrial index each increased by 0.15%, 0.03%, and 0.17%, respectively. Meanwhile, trading activity was subdued, with the volume of stocks traded declining by 71.90% to 210.84 million units and the total value of stocks traded decreasing by 58.78% to N2.19 billion. Given the conclusion of the DMO August auction, NIBOR surged across all tenor buckets tracked amid financial sector liquidity tightness; similarly, NITTY jumped across the board for all maturities measured on renewed sell pressure. In the OTC bond market, the values of FGN bonds stayed steady for all maturities tracked, however, the prices of FGN Eurobonds declined as bearish activity increased.
