



Cowry Daily Market Insight 17 August 2022

Sell-Pressure Dragged The NGX Into The Bear After Tuesday's Dead Cat Bounce, While Yields on FGN Eurobond Cleared Lower....


It was a lackluster performance at the equities market midweek with a bearish close of 0.04% after the dead cat bounce witnessed on Tuesday. Thus, the NGX-ASI and market capitalization of listed equities trended lower by 4bps to close at 49,691.17 and N26.80 trillion respectively while the index's year-to-date return tanked 16.3% even as the Exchange reported more laggards (16) than gainers (10). Accordingly, COURTVILLE (9.80%), led the chart of the decliners and trailed by SCOA (9.79%), SKYAVN (9.73%), REGALINS (8.00%) and HONYFLOUR (5.36%) while the likes of PRESTIGE (9.09%), SOVRENINS (8.00%), LASACO (6.48%), and UNITYBNK (4.65%) topped the gainers' chart. On Wednesday, we saw three of the five indexes (NGX Banking index, NGX Oil/Gas index, and NGX Consumer Goods index) under our purview lagged by 0.21%, 0.15% and 0.07% respectively resulting from waning investors' sentiment in the stock market while the Insurance index saw gains of 0.86% and the Industrial Index closed flat. Although, the market activity was mixed today, we saw the total value of traded securities advanced by 151.45% to N4.12 billion, while the volume of equities dipped by 36.92% to 128.79 million units. Elsewhere, in the money market, it was a mixed bag as NIBOR spiked upward while NITTY trended lower for the majority of tenor buckets. In the bond market, the yields on FGN bonds traded mute while the FGN Eurobond yields cleared lower for the short, mid and long ends of the curve.
