Bears tighten grip on the Equity market, as NGX-ASI Falls by 35bps; NIBOR Falls for all Tenor Buckets amid Sustained Liquidity Ease...


The NGX All Share Index (ASI) decreased by 0.35% as a result of weak investor sentiment, with the Exchange recording 15 losers and 14 gainers at the close of trade. Consequently, the local bourse's year-to-date gain moderated to 15.58%. In particular, sell pressure persisted as share prices of tickers including UPL, HONEYFLOUR, WAPCO, NEM, ARDOVA, and ACCESSCORP dropped by 9.5%, 8.33%, 4.01%, 3.78%, 2.78%, and 0.60%, respectively. Despite the persisting bearish sentiment, performance across sub-sector gauges was positive, with the NGX Banking index, NGX Insurance index, and NGX Consumer Goods index increasing by 0.23%, 0.13%, and 0.06%, respectively. On the flip side, the NGX Oil/Gas index and the NGX Industrial index both slid by 0.15% and 0.32%, respectively. Meanwhile, market activity was subdued today, with the number of shares traded declining by 10.04% to 132.23 million units and the total value decreasing by 38.64% to N1.63 billion. Elsewhere, NIBOR declined for the majority of tenor buckets tracked as a result of the continuous liquidity boost in the financial system. However, NITTY moved in mixed directions. In the OTC bond market, the value of FGN bonds remained flat for all tracked maturities. However, the value of FGN Eurobonds declined for all tracked maturities as a result of persistently negative sentiment.
