Equity Market Rises by 0.04%, to Close Trading Week in The Green; NIBOR Falls for all Tenor Buckets amid Liquidity Ease...

The local bourse maintained its positive trend, with its All-share index rising by 0.04% to close at 49,682.15 points even as the number of gainers (18) outweighed that of the losers (15) at the close of the trading session. Consequently, the year-to-date gain of the local bourse rose to 16.31%. Specifically, blue-chip stocks such as NESTLE, FBNH, and GTCO enjoyed investors' patronage as their respective share prices inched higher by 3.26%, 0.93%, and 0.66%, respectively. Notably, the NGX Consumer Goods index rose by 0.51%, boosted by Nestle's buy pressure. Sector performance remained subdued, with three of the five sub-sector indices closing in the negative, with the exception of the NGX Oil/Gas index, which gained by 0.16%. The NGX Banking, NGX Insurance, and NGX Industrial indices all fell by 0.67%, 0.39%, and 0.01%, respectively. Meanwhile, trading activity was mixed, with the number of shares moved decreasing by 5.92% to 193.51 million units. However, the total value ballooned by 67.93% to N4.64 billion. In the money market, NIBOR moderated for the majority of tenor buckets as financial system liquidity pressure eased, with the open buyback rate and the overnight lending rate falling by 8bps and 9bps, respectively, to 13.50% and 13.67%. NITTY fell for all maturities tracked on buy pressure. In the OTC bond market, the values of FGN bonds were muted for all maturities tracked. Meanwhile, the value of FGN Eurobonds declined across the board for all maturities as bearish sentiment resurfaced.




