**Bearish Sentiment Persist, as NGX-ASI Dropped by 0.69%; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Boost...**

The domestic bourse index dwindled by 0.69% to close lower at 49,644.92 points even as the Exchange printed 18 losers against 11 gainers at the session's close. The share price declines of ZENITHBANK (-3.57%) and AIRTELAFRI (-1.96%) contributed to the equity market's poor performance today. Other large-cap stocks, including FBNH (-1.87%), NB (0.62%), and GTCO (0.50%), also contributed to today's stock market decline. As a result, the local bourse's year-to-date gain plummeted to 16.22%. However, performance across sub-sector gauges tracked was varied, with only the NGX Consumer Goods and NGX Industrial indices advancing by 0.16% and 0.04%, respectively. On the other hand, the NGX Banking and NGX Insurance indices fell by 1.31% and 0.06%, respectively, while the NGX Oil/Gas index remained unchanged. In other news, the total value of stocks traded declined 88.50% to N2.73 billion, with the volume of stocks exchanged decreasing 30.82% to 138.99 million units. The open buyback rate and the overnight lending rate both decreased by 3 bps to 12.33% and 12.83%, respectively, in the money market, as NIBOR moderated for the majority of maturities tracked on sustained financial system liquidity ease. NITTY also fell for the majority of tenor buckets monitored amid buy pressure. In the OTC bond market, the values of FGN bonds traded were flattish for most maturities tracked. However, the value of FGN Eurobonds increased for most maturities tracked amid buy pressure.




