



Equities Market Closes Flat as Investors Gain N1.09 billion; NIBOR Falls for All Maturities on Financial Liquidity Ease...

The domestic stock market index closed slightly firmer following a choppy day on Tuesday as stocks battled to find direction. Consequently, the year-to-date gain of the local bourse remained unchanged at 16.18% despite the Exchange printing a higher number of losers (16) than gainers (13). Notably, at the close of trading today, MULTIVERSE gained 10.00% to lead the best five-performing stocks. FIDELITYBK (+3.02%), HONEYFLOUR (+2.64%), and WAPCO (+1.65%) also closed positive, while REDSTAREX (-10.00%), COURTVILLE (-2.08%), TRANSCORP (-0.93%), DANGSUGAR (-0.60%), and ZENITHBANK (-0.25%) closed negative. However, performance across sub-sector gauges tracked failed to reflect market performance, as three of the five indices tracked closed in the red, with the NGX Banking index, NGX Insurance index, and the NGX Consumer Goods index sliding by 0.09%, 1.12%, and 0.02%, respectively. The NGX Industrial indices gained by 0.14%, while the NGX Oil/Gas index remained unchanged. Elsewhere, market activity was brisk today, as the volume and value of stocks traded increased by 85.05% and 277.17% to N160.24 million and N1.49 billion, respectively. ZENITHBANK (536.65 million shares), COURTVILLE (11.33 million shares), and TRANSCORP (16.99 million shares) were the three most actively traded equities by volume; by value, ZENITHBANK (N536.65 million), MTNN (N178.05 million), and GTCO (N140.13 million).







Money Market

NIBOR decreased for all maturities tracked as banks with liquidity demanded lower rates. As a result, the overnight lending rate and open buyback rate both declined by 35 basis points (bps) to 7.50% and 8.00%, respectively. NITTY, on the other hand, moved in mixed directions.

Bonds Market

FGN bond values remained unchanged in the OTC bond market for the majority of maturities tracked. On the flip side, the value of FGN Eurobonds depreciated for most maturities due to renewed sell pressure.

Foreign Exchange Market

The Naira strengthened against the US dollar at the I&E windows, rising 0.11% to N436.04 from N436.50. However, the parallel market rate remained unchanged at N708.

Global Oil Market

As of 4:00 PM GMT+1, Brent crude is down 0.53% to \$87.31 a barrel. Likewise, WTI crude oil fell 1.18% to \$92.89 per barrel. This was driven by the high US August inflation figure being greater than market projections, prompting fears of another significant interest rate hike by the US Federal Reserve next week.
