




## Domestic Bourse Index Falls by 0.13% amid Sell-offs on Banking Shares; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Squeeze...

The local equity market closed in red for the last trading day of the week as its All Share Index (ASI) moderated by 0.13% to close at 49,475.42 points; even as the Exchange recorded more losers (13) than gainers (9). Hence, the year-to-date performance of the NGX ASI slipped to 15.82%. Specifically, investors booked profits on banking stocks such as ACCESSCORP, UBA, STANBIC, and FBNH; their share prices fell by 5.14%, 4.70%, 1.67%, and 1.48%, respectively. Consequently, the NGX Banking index suffered a loss of 1.39%. On the positive side, the NGX Insurance index and the NGX Consumer Goods index rose by 0.65% and 0.02%, respectively. The NGX Oil/Gas indices and the NGX Industrial index remained unchanged. Meanwhile, trading activity was subdued, with total deals, volume, and stock exchanged declining by 4.48%, 35.87%, and 9.04%, respectively, to 3,303 trades, 107.49 million units, and N1.15 billion. FBNH was the most active stock in terms of volume, with 12.02 million of its shares, worth N120.67 million, changing hands in 194 deals. By turnover, ZENITHBANK had the most traded stock at N235.91 billion.



## Money Market

NIBOR rose for all the tenor buckets tracked as banks with liquidity requested higher rates, with the overnight lending rate and the open buyback rate rising 38 bps and 0.36 bps to 9.67% and 10.17%, respectively. Meanwhile, NITTY moved in mixed directions.

## Bonds Market

For the bulk of the maturities tracked, FGN bond prices were unchanged in the OTC bond market as investors continued to play in the short-to-medium portions of the yield curve while carefully choosing their long-dated positions. On the flip side, the value of FGN Eurobonds depreciated for all maturities tracked on renewed bearish sentiment.

## Foreign Exchange Market

At the I&E windows, the Naira slightly strengthened versus the US dollar, rising 0.02% to N436.25 from N436.33. The parallel market rate, however, remained unchanged at N709.

## Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is up 0.66% to \$91.44 a barrel. Likewise, WTI crude oil rose 0.77% to \$85.76 per barrel. However, oil prices are on track to post another weekly loss as investors' economic slowdown concerns continue to outweigh the risks of a supply drop. The stronger dollar also made oil less affordable for buyers. Earlier in the week, OPEC and the IEA stated that they saw demand rising by between 2% and 3% in the foreseeable future.
