



Local Equities Market Index Closes in Negative Territory as the ASI Falls by 0.42%; NIBOR Falls for most Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse All-Share Index (ASI) moderated by 0.42% to close at 48,964.83 points following a sell-off on mid and large-cap stocks. Consequently, the year-to-date gain of the NGX ASI declined to 14.64% even as the number of losers (14) outweighed that of the gainers (12). Specifically, market sentiment shifted negative as investors liquidated a portion of their positions in Tickers such as NESTLE, FCMB, AIICO, and UBA. Their respective share prices fell by 10.00%, 6.00%, 5.45%, and 2.11%, respectively. The breakdown among sub-sectors indicated that four of the five indices tracked closed in the red zone: the NGX Banking Index, NGX Insurance Index, the NGX Consumer Goods, and the NGX Oil/Gas Index slid by 0.15%, 0.58%, 3.22%, and 0.03% respectively. The NGX Industrial index remained unchanged. Elsewhere, market activity expanded today, with total volume and value rising by 117.37% and 88.03%, respectively, to 220.78 million units and N2.25 billion. However, the total deals fell by 22.00% to 3,105 trades. In terms of volume, JAIZBANK was the most active stock, with 85.91 million shares worth N65.09 million changing hands in 105 trades.







Money Market

As banks seeking lower rates sought lower rates, NIBOR fell across the board for the majority of maturities tracked, with the open buyback rate and the overnight lending rate both lowering to 16.5%.

NITTY, on the other hand, climbed across all tenor buckets tracked amid persistent sell pressure.

Bond Market

In the OTC bond market, the values of FGN bonds traded were flattish for most maturities tracked.

However, the value of the FGN Eurobond fell further for all maturities tracked as investors continued to demand higher yields.
