## Cowry Daily Market Insight 19 October 2022

Local Bourse Continues Bearish Sentiment as NGX All Share Index tumbles further by 2.31%; NITTY Rises for All Tenor Buckets on Sell Pressure...

On Wednesday, the domestic bourse All-Share Index (-2.31%) was reeling from a third consecutive day of losses as telecom heavyweight AIRTELAFRI (-10.00%) experienced another major selling episode. Hence, the year-to-date gain of the index slumped to 3.75% – dangerously close to negative territory. Similarly, the exchange also printed a higher number of losers (17) than gainers (16) amid sustained bearish activity. Notably, share prices of tickers such as MRS, WAPCO, TOTAL, MTNN, DANGSUGAR, and GTCO fell by 10.00%, 9.76%, 7.83%, 6.68%, 2.01%, 1.92%, and 0.54%, respectively. On the flip side, investors reacted to FIDELITYBK's redemption of its \$400 million Eurobond notes, propelling it to the top of the gainer's chart (+9.74%). Performance across sub-sector gauges was relatively positive today except for, the NGX Consumer Goods index and the NGX Oil/Gas index, which declined by 0.03% and 0.80% respectively. The NGX Banking index, NGX Insurance index, and NGX Industrial index all increased—respectively by 0.50%, 0.24%, and 0.94%. Elsewhere, market activity came in weak today as the total deals and volume decreased by 8.69% and 60.66%, respectively, to 3,183 trades and 165.35 million units. In terms of volume, FBNH was the most active stock, with 48.09 million shares worth N461.77 million changing hands in 99 deals.

#### Money Market

NIBOR jumped across the board for the majority of maturities tracked as banks with liquidity demanded higher rates, despite the overnight lending rate and the open buyback rate concluding flat at 16.25% and 16.50%, respectively.

Similarly, NITTY increased across all tenor buckets tracked under renewed sell pressure.

### Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds remained unchanged for most maturities tracked as investors stayed on the sidelines.

On the flip side, the values of the FGN Eurobond fell for most maturities tracked amid sustained bearish sentiment.

### Foreign Exchange Market

At the I&E windows, the Naira lost 0.06% against the US dollar, falling to N441.50 from N441.25. The parallel market rate fell by 0.81% to N745 from N739.

### **Global Oil Market**

As of 4:00 p.m. GMT+1, Brent crude is up 0.44% to \$90.43 a barrel. Likewise, WTI crude oil rose 0.81% to \$83.49 per barrel.

On Wednesday, oil prices rose as a result of unexpectedly low US oil stockpiles (down 1.7 million barrels) and expectations of tighter global supply. These factors outweighed the negative effects of a stronger dollar and the possibility of the US releasing 15 million barrels of oil from its emergency reserves to offset rising gasoline prices.
