Domestic Bourse Ends the Week in Green, as NGX-ASI Rises by 15bps; NITTY Rises for all Tenor Buckets amid Sustained Bearish Sentiment...

The local bourse maintained its positive trend for the second straight day of trading, with its All-share index rising by 0.15% to close at 44,396.73 points even as the number of gainers (16) outweighed that of the losers (15) at the close of today's session. Consequently, the year-to-date gain of the local bourse rose to 3.93%. Specifically, large and mid-cap stocks such as DANGSUGAR, BUACEMENT, FIDELITYBK, and GTCO enjoyed investors' patronage as their respective share prices inched higher by 2.52%, 1.64%, 0.80%, and 0.27%, respectively. Sectorial performance was a mixed bag, as the NGX Banking index and the NGX Insurance index declined by 0.35% and 3.48%, respectively, while the NGX Consumer Goods index and the NGX Industrial index advanced by 0.15% and 0.77%, respectively. The NGX Oil/Gas index remained flat. Elsewhere, market activity came in weak today with total deals, volume, and value sliding by 0.72%, 20.16%, and 41.14%, respectively, to 2,888 trades, 95.18 million units, and N1.88 billion. In terms of volume, FIDELITYBK was the most active stock, with 26.59 million shares worth N100.68 million changing hands in 180 deals.







Money Market

NIBOR rose across the board for the majority of maturities tracked as banks with liquidity demanded higher rates, even as the overnight lending rate and the open buyback rate climbed to 16.50% and 16.33%, respectively.

Similarly, NITTY increased across all tenor buckets tracked under renewed sell pressure.

Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds remained unchanged for most maturities tracked as investors stayed on the sidelines.

On the flip side, the values of the FGN Eurobond fell for most maturities tracked amid sustained bearish sentiment.

Foreign Exchange Market

At the I&E windows, the Naira lost 0.12% against the US dollar, falling to N441.67 from N441.13. The parallel market rate fell by 0.27% to N747 from N745.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is up 0.30% to \$92.66 a barrel. However, WTI crude oil fell 0.32% to \$84.24 per barrel.

Oil prices rose on Friday in choppy trade as positive sentiment continued to weigh on markets, with the prospects of tighter global supply – stronger Chinese demand and further output cuts by OPEC + in the short-term outweighing demand constraints – Further rates hike from Central Banks as well.
