Equities Market Index Advances by 0.15% amid Sustained Bullish Activity; NITTY Falls for All Tenor Buckets on Buy Pressure...

The local bourse All-Share Index advanced by 0.15% to close at 44,461.63 amid sustained bargain-hunting activity despite the number of losers (18) recorded outweighing that of the gainers (8) at the close of the trading session. Consequently, the year-to-date gain of the NGX ASI rose to 4.09%. Notably, mid and large-cap stocks such as BETAGLASS, WAPCO, ARDOVA, and MTNN were the toast of investors today as their respective share prices rose by 5.90%, 2.73%, 2.19%, and 1.28%. On the flip side, UNILEVER's share price sank by 10.00% following the disappointing nine-month 2022 earnings result and was followed by NEM (-9.50%), LASACO (-4.60%), and REGALINS (-4.17%). Despite the benchmark index's upward movement, performance across sub-indices was negative with the NGX Banking, NGX Insurance index, NGX Oil/Gas index, and the NGX Consumer Goods index declining by 0.37%, 1.63%, 0.28%, and 0.38%, respectively. On the other hand, the NGX Industrial index rose by 0.22%, driven by WAPCO and BETAGLASS share price appreciation. Elsewhere, market activity came in weak today, with total deals and volume sliding by 0.03% and 24.01%, respectively, to 2,887 trades and 72.33 million units. In terms of volume, TRANSCORP was the most active stock, with 11.35 million shares worth N11.93 million changing hands in 56 deals.







## Money Market

NIBOR moved in mixed directions.

However, NITTY decreased across all tenor buckets tracked under renewed buy pressure.

## Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds remained unchanged for most maturities tracked as investors stayed on the sidelines.

On the flip side, the values of the FGN Eurobond rose for most maturities tracked amid renewed bullish sentiment.

## Foreign Exchange Market

At the I&E windows, the Naira gained 0.07% against the US dollar, rising to N441.38 from N441.67. However, the parallel market rate fell by 1.07% to N755 from N747.

## Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is up 0.11% to \$93.60 a barrel. However, WTI crude oil fell 0.04% to \$85.01 per barrel.

Oil prices rose on Monday as a general expectation of less aggressive rate hikes by the US Federal Reserve as a result of weaker US business data activity outweighed demand constraints from weak Chinese customs data indicating lower energy demand.
