



Renewed Bullish Sentiments in Bellwethers Stocks Drove 4bps Rally on the Bourse; NIBOR Rises for most Tenor Buckets amid Sustained Liquidity Squeeze...

After the bearish outing reported on Tuesday, the local bourse benchmark index rose by 0.04% to close at 43,477.48 points, principally buoyed by renewed positive investor sentiment on some of the bellwethers such as UBA, DANGCEM, GTCO, and ZENITHBANK. Hence their respective share prices increased by 1.43%, 0.59%, 0.29%, and 0.25%. Resultantly, the Exchange printed more gainers (12) than losers (11) at the close of the trading session, prompting the year-to-date gain of the NGX ASI to inch further by 1.78%. However, sectorial performance remained bearish as three out of the five indices under our purview closed in the red zone; thus; the NGX Oil/Gas index led the laggards by 0.67%, followed by the NGX Insurance index and the NGX Consumer Goods index by 0.38% and 0.17%, respectively. On the positive side, the NGX Banking Index and the NGX Industrial Index both increased by 0.27% and 0.20%, respectively. In the meantime, market activity came in weak today, with total deals, volume, and value declining by 6.24%, 46.62%, and 27.62%, respectively, to 3,078 trades, 133.41 million units, and N1.81 billion. In terms of volume, FBNH was the most active stock, with 30.38 million shares worth N303.74 million changing hands in 113 deals.







Money Market

NIBOR increased across the board for the majority of maturities tracked as banks with liquidity requested higher rates, even as the overnight lending rate rose marginally to 8.83%.

Meanwhile, NITTY fell for most maturities tracked, despite the average yield in the T-bill secondary market staying unchanged at 10.92%.

Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds were largely flat for most debt instruments as the average secondary market remained unchanged at 14.56%.

Meanwhile, the value of the FGN Eurobond increased further for all maturities tracked on sustained bullish sentiment. Hence, the average yield contracted by 0.45 percentage points to 12.60%.

Foreign Exchange Market

At the I&E windows, the Naira strengthened against the US dollar, rising 0.10% to N445.67 from N446.10. Similarly, at the parallel market, the Naira edged over the dollar as it increased by 3.39% from N852.95 to N824 on the back of calm speculative buying of the greenback. Hence, currency traders kept offers for the greenback between N815 and N850.

Global Oil Market

As o 3:30 p.m. GMT+1, Brent crude is down 1.11% to \$94.31 a barrel. Similarly, WTI crude oil fell 1.48% to \$87.59 per barrel.

Oil prices fell further on Wednesday as the US EIA reported that crude oil stocks in the United States increased by 5.6 million barrels in the week ending November 4th, above market expectations of a 1.1 million barrel increase. Rising COVID-19 cases in key Chinese cities have also contributed to the current slump in oil prices as energy demand concerns persist.
