



Waning Sentiments set in as NGX All Share Index Losses 0.25%; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

The bears return to the equities space after six consecutive days of an uninterrupted bullish streak as the NGX-ASI fell by 0.25% to close at 47,436.45 points today, mainly due to weak investors' appetite for industrial and banking stocks. Hence the year-to-date gain of the index fell to 11.05% even as the Exchange printed a higher number of losers (17) than gainers (15). Notably, BETAGLAS (-9.90%) led the top losers' chart at the close of trading today. The Tier-1 banks pushed the decline as ACCESSCORP (-1.16%), UBA (-0.68%), and GTCO (-0.25%) recorded losses in share prices, while BUACEMENT (-2.78%) led the decline in the Industrial Index. Despite the pessimistic attitude in the equity market, most sub-sector gauges closed higher, particularly the NGX Insurance index, which rose by 1.43%. Additionally, the NGX Consumer Goods index and the NGX Oil/Gas index both increased by 0.02% and 0.09%, respectively. The NGX Consumer Goods Index and the NGX Industrial Index were the exceptions, falling by 0.22% and 1.31%, respectively. Meanwhile, activity in the market was upbeat as total deals and volume increased by 36.01% and 182.15%, respectively, to 3,781 trades and 279.28 million units. In terms of volume. REGALINS was the most active stock, with 97.63 million shares worth N23.43 million changing hands in 6 deals.







Money Market

NIBOR fell across the board for most maturities tracked as banks with liquidity sought lower rates. However, short-term benchmark rates, such as the Open Buyback Rate (OPR) and the Overnight Lending Rate (OVN), widened respectively to 13.75% and 14.13% amid tighter financial system liquidity. Meanwhile, NITTY rose for most tenor buckets tracked despite the average yield on T-bills in the secondary market contracting to 10.51% amid sustained demand pressure on the 16 March 2023 T-bills (+223 bps).

Bond Market

In the OTC bond market, the values of plain vanilla FGN Bonds were flat for the majority of maturities tracked despite the average secondary market yield expanding by 0.02 ppt to 14.40% amid bearish sentiment. Meanwhile, the value of the FGN Eurobond decreased for all maturities tracked amid renewed bearish sentiment. Hence, the average yield expanded by 0.19 ppt to 11.83%.

Foreign Exchange Market

At the I&E windows, the Naira gained 0.37% against the US dollar, rising to N444.7 from N446.33. The parallel market rate, however, remained constant at N775.

Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is down 3.06% to \$81.07 a barrel. Meanwhile, WTI crude oil fell 2.59% to \$74.30 per barrel.

Oil prices fell on Monday as a result of widespread street protests in China over the country's strict COVID-19 policy, as well as rumors that the US has granted Chevron Corp a license to produce oil in Venezuela, dampening investors' expectations for increased energy demand in the near future.
