




## Nigerian Equities Market Revs by 1.07% on BUACEMENT Shares; NIBOR Falls for Most Maturities on Financial System Liquidity Ease...

The domestic equity market All-Share Index (ASI) ballooned by 1.07%, climbing to 48,881.93 points as investors committed more funds to buy BUACEMENT (+9.17) shares today. Other companies such as WAPIC (+8.11), ETI (+3.70), UBA (+1.37%), and OANDO (+1.03%) also enjoyed investors' patronage, hence making the number of gainers (17) stand above that of the losers (10) at the close of the trading session. Hence, the year-to-date gain of the local bourse rose to 14.43%. Given the appreciable capital gain in BUACEMENT shares, we saw the industrial index rise by 4.33% to close at 2,319.40 points. Notably, other sub-sector witnessed a bullish rally as the NGX Banking, NGX Insurance, NGX Consumer Goods, and the NGX Oil/Gas indexes advanced by 0.13%, 0.30%, 0.12%, and 0.03%, respectively. Meanwhile, trading activity fell as total deals, volume, and value decreased by 28.04%, 31.95%, and 61.63%, respectively, to 2,440 trades, 100.82 million units, and N1.14 billion. In terms of volume. FBNH was the most active stock, with 34.19 million shares worth N46.19 million changing hands in 35 deals.



## Money Market

NIBOR fell across the board for most of the maturities tracked as banks with liquidity sought lower rates. However, short-term benchmark rates, such as the Open Repo (OPR) and the Overnight Lending Rate (OVN), widened further to 13.63% (from 10.88%) and 14.13% (from 11.00%), respectively.

Meanwhile, NITTY declined across all tenor buckets tracked, despite the average yield on T-bills in the secondary market remaining relatively unchanged at 8.47%.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN Bonds remained relatively flat for the bulk of maturities examined despite the average secondary market yield compressing marginally by 1 bps to 14.09% (from 14.10%). Notably, the yield on the 20-year bond rose to 16.00% (from 15.87%) amid sell pressure after yesterday's rally, while the yields on the 10-year, 15-year, and 30-year debt instruments remained unchanged at 13.95%, 14.43%, and 14.72%, respectively, from the previous day as traders remained on the sidelines.

Elsewhere, the value of the FGN Eurobond rebounded for the majority of maturities tracked amid renewed bullish sentiment and sell pressure on the local currency. Hence, the average yield contracted by 3 bps to 11.0%.

## Foreign Exchange Market

At the I&E windows, the Naira lost 0.11% against the US dollar, falling to N446.50 from N446.00. Similarly, the parallel market rate decreased by 0.54%, falling from N747 to N743.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is up by 0.43% to \$76.48 a barrel. Similarly, WTI crude oil rose 0.42% to \$71.76 per barrel.

On Friday, oil futures rose as traders assessed the impact of Russia's oil price cap and China's improving energy demand outlook against lingering demand fears of a global economic slowdown.
