



## Equities Market Sustains Bullish Trend as ASI Rises Marginally by 4bps; NIBOR Rises for most Tenor Buckets amid Liquidity Strain...

The local bourse resumed the trading week positively as it rose marginally by 0.04% to 48,899.08 points amid sustained bullish activity despite the Exchange printing 12 losers as against 10 gainers at the close of the trading session. Hence, the year-to-date gain of the NGX ASI advanced to 14.47%. Specifically, tickers such as JAIZBANK, SCOA, FBNH, and ZENITHBANK advanced by 9.20%, 8.86%, 1.85%, and 1.58%, respectively, amid positive sentiment. Performance across sub-sector gauges was a mixed bag as the NGX Banking Index and the NGX Industrial Index rose by 0.47% and 0.04%, respectively, while the NGX Insurance Index fell by 0.61%. The NGX Consumer Goods index and the NGX Oil/Gas index remained unchanged from the previous day. Meanwhile, trading activity rebounded as total deals, volume, and value increased by 36.64%, 134.65%, and 120.07%, respectively, to 3,334 trades, 236.59 million units, and N2.52 billion. In terms of volume, ACCESSCORP was the most active stock, with 120.98 million shares worth N1.03 billion changing hands in 172 deals.







## Money Market

NIBOR rose across the board for most of the maturities tracked as banks with liquidity sought higher rates. Likewise, short-term benchmark rates, such as the Open Repo (OPR) and the Overnight Lending Rate (OVN), widened further to 15.75% (from 13.63%) and 16.25% (from 14.13%), respectively.

Meanwhile, NITTY fell across all tenor buckets tracked, even as the average secondary market yield on T-bills fell to 8.31% due to demand pressure on long-term assets, particularly the Nov 23 2023 T-bill (-2.49%).

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN Bonds remained relatively flat for the bulk of maturities examined, despite the average secondary market yield staying steady at 14.09%. Notably, the yields on 10-year, 15-year, 20-year, and 30-year debt instruments were steady from the previous day at 13.95%, 14.43%, 16.00%, and 14.72%, respectively.

Elsewhere, the value of the FGN Eurobond declined for the majority of maturities tracked as bearish sentiment returned. Consequently, the average yield expanded by 2 bps to 11.69%.

## Foreign Exchange Market

The Naira gained 0.11% against the dollar at the I&E windows, climbing to N446.00 from N446.50. Likewise, the parallel market rate rose by 0.54%, rising from N743 to N747.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is up by 2.11% to \$77.70 a barrel. Similarly, WTI crude oil rose 3.03% to \$73.17 per barrel.

Oil futures advanced on Monday as traders assessed the impact of the Keystone pipeline closure, which supplies oil to the U.S., and possible Russian production cuts.
