



Nigerian Stock Exchange Index Further Rises by 0.17% amid Sustained Buy-Pressure; NIBOR Rises for most Tenor Buckets on Renewed Liquidity Squeeze...

The domestic bourse closed the week in positive territory as the index rose by 0.17% to settle at 49,316.29 points amid sustained bullish activity; hence, the year-to-date gain of the local bourse climbed to 15.45%. Also, the Exchange recorded more gainers (17) than losers (11) at the close of the trading session. Specifically, we saw bargain-hunting activity on medium- and large-cap stocks such as PZ, GEREGU, ZENITHBANK, GTCO, and FIDELITYBK. Hence, their respective share prices advanced by 9.73%, 3.92%, 2.55%, 1.95%, and 1.19%. Sectorial performance was strong as three out of the five indices closed in green, with the NGX Banking, NGX Insurance, and NGX Consumer Goods indexes increasing by 1.09%, 0.56%, and 0.08%, respectively. On the flip side, the NGX Insurance index fell by 0.11%, while the NGX Industrial index remained unchanged from the previous day. Meanwhile, trading activity was downbeat, as total volume, and values decreased by 53.45% and 5.73%, respectively, to 103.71 million units and N2.01 billion. In terms of volume. ZENITHBANK was the most active stock, with 14.13 million shares worth N338.03 million changing hands in 287 deals.







Money Market

NIBOR rose across the board for the majority of maturities tracked as banks with liquidity sought higher rates. Short-term benchmark rates, such as the Open Repo Rate (OPR) and the Overnight Lending Rate (OVN), narrowed to 9.63% (down from 11.63%) and 10.50% (down from 11.75%), respectively.

Meanwhile, NITTY fell for the bulk of tenor buckets tracked, likewise, the average secondary market yield on T-bills declined marginally to 8.23%.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the bulk of maturities examined, despite the average secondary market contracting by 20bps to 13.47%. Notably, the yields on the 30-year debt decreased further, respectively, to 14.00% (from 14.22%) amid sustained demand pressure. Conversely, the yields on the 10-year, 15-year, and 20-year bonds were relatively unchanged from the previous day at 13.94%, 14.00%, and 14.44%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for all of the maturities tracked due to sustained bearish sentiment. Consequently, the average yield expanded by 18 bps to 11.71%.

Foreign Exchange Market

The Naira lost 0.04% against the dollar at the I&E windows, decreasing to N451.50 from N451.33. However, the parallel market remained unchanged from the previous day at N745.

Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is down by 3.12% to \$78.68 a barrel. Similarly, WTI crude oil fell 3.19% to \$73.68 per barrel.

Oil prices fell amid recession fears in the US and advanced economies given the recent rate hikes by major central banks.
