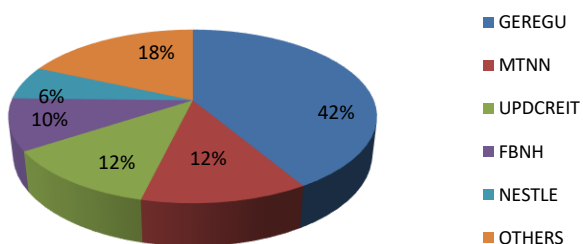

## Local Bourse All-Share Index Rises by 0.12% amid Bargain Hunting Activity; NIBOR Falls for Most Tenor Bucket on Liquidity Ease...

The NGX All-Share index rose by 0.12% to close at 49,475.43 points amid sustained bargain-hunting activity, even as the Exchange printed a higher number of gainers (21) than losers (11). Specifically, we saw bullish sentiment on symbols such as CHAMPION (+4.88%), FBNH (+3.74%), GTCO (+1.71%), NAHCO (+1.71%), and UCAP (+1.48%). Hence, the year-to-date gain of the index rose to 15.83%. On the flip side, JAPAUFGOLD share price fell by 3.70%, followed by MBENEFIT (-3.45%), FTNCOCOA (-3.33%), and WEMABANK (-2.73%). Given the bullish sentiment, performance across sub-sector gauges was positive, as the NGX Banking index, NGX Consumer Goods index, and NGX Oil/Gas index rose by 0.22%, 0.05%, and 0.08%, respectively. However, the NGX Insurance index fell by 0.14%, and the NGX Industrial index remained unchanged from the previous day. Meanwhile, trading activity was upbeat, as total volume, and value ballooned by 310.77%, and 389.87%, respectively, to 411.15 million units and N6.35 billion. In terms of volume. UPDCREDIT was the most active stock, with 245.33 million shares worth N760.47 million changing hands in 31 deals.

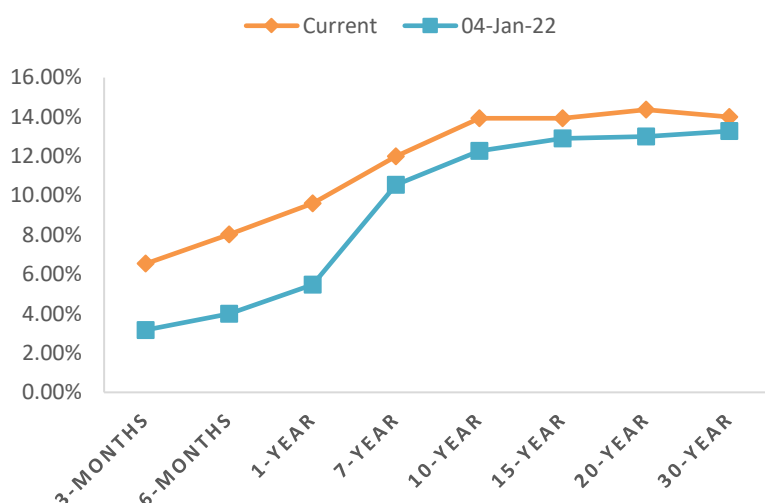

## Money Market

NIBOR fell across the board for the majority of maturities tracked as banks with liquidity sought lower rates. However, short-term benchmark rates, such as the Open Repo Rate (OPR) and the Overnight Lending Rate (OVN), widened to 10.25% (up from 7.50%) and 10.63% (down from 10.25%), respectively.

Meanwhile, NITTY moved in mixed directions, although the average secondary market T-bill yield crashed marginally to 5.60% on demand pressure.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the bulk of maturities examined, despite the average secondary market contracting 16bps to 13.27%. Notably, the yields on the 15-year and the 20-year debt decreased to 13.93% (from 14.00%) and 14.37% (from 14.48%) on buy interest. Meanwhile, the yields on the 10-year and 30-year bonds were unchanged from the previous trading day at 13.94%, and 14.00%, respectively.

Elsewhere, the value of the FGN Eurobond increased for all of the maturities tracked due to renewed bullish sentiment. Consequently, the average yield compressed by 9bps to 12.03%.

## Foreign Exchange Market

At the I&E windows, the Naira depreciated from N452.67 to N456.33 against the US dollar. Likewise, the parallel market rate declined by 0.13% to N747 from N746.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is up by 1.73% to \$77.74 a barrel. Similarly, WTI crude oil rose 1.98% to \$77.74 per barrel.

Oil futures gained on Wednesday as a result of an unexpectedly larger US oil stockpile drain (down 3.1 million barrels) and anticipation of an improved Chinese energy demand outlook.
