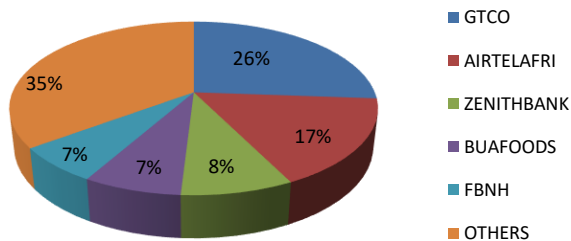

## Domestic Equities Market Reverses Uptrend as Index Drops by 1.89%; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

The local bourse All-Share Index tanked by 1.89% to 50,868.52 points amid renewed profit-taking activity, particularly on AIRTELAFRI (-8.26%), NAHCO (-3.90), NGXGROUP (-3.60), STERLNBANK (-2.10), and FBNH (-0.45) shares. Consequently, the year-to-date gain of the local bourse slipped into negative territory at -0.75% despite the bulls (20) outnumbering the bears (16). Performance for most sub-sectors was bullish, as three of the five sub-indices closed positive: the NGX Banking, the NGX Consumer Goods, and the NGX Oil/Gas indices rose by 0.88%, 1.33%, and 0.09%, respectively. On the flip side, the NGX Insurance index moderated by 0.97%, while the NGX Industrial index remained relatively unchanged from the previous day. Meanwhile, trading activity mellowed, with the total number of deals, volume, and value decreasing by 11.62%, 47.80%, and 86.49%, respectively, to 3,673 trades, 138.72 million units, and N1.83 billion. In terms of volume, STERLNBANK was the most active stock, with 29.15 million shares worth N41.01 million changing hands in 57 deals.

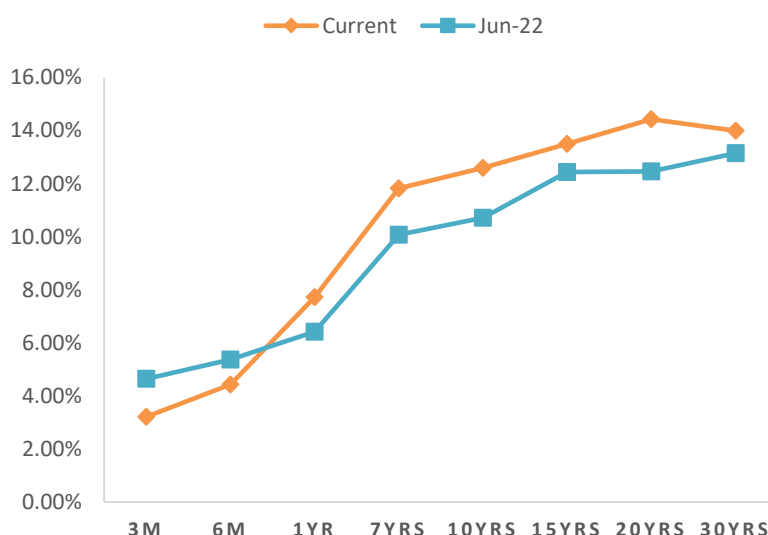

## Money Market

NIBOR declined across the board for all of the maturities tracked as banks with liquidity sought lower rates. Short-term benchmark rates, on the other hand, such as the open repo rate (OPR) and the overnight lending rate (OVN), remained stable at 9.50% and 9.83%, respectively.

Meanwhile, NITTY fell across the board for all tenor buckets tracked, even as the average secondary market T-bill yield fell to 3.64% on sustained buy pressure, notably on longer-dated maturities.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained flat for most maturities monitored. In contrast, the average secondary market fell 2bps to 12.70%. Notably, the yields on the 10-year, 15-year, 20-year, and 30-year bonds were unchanged from the previous trading day at 12.60%, 13.50%, 14.43%, and 14.00%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for all of the maturities tracked as bearish sentiment crept in. Consequently, the average secondary market yield increased by 4 bps to 11.45% as investors digested the US Federal Reserve's hawkish comments.

## Foreign Exchange Market

In FX, the Naira appreciated against the greenback at the I&E windows, gaining 0.04% to ₦461.50 (from ₦461.67). Furthermore, the parallel market rate rose by 0.14% to ₦739 from ₦740.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 0.75% to \$78.42 a barrel. Similarly, WTI crude oil rose 0.31% to \$73.07 per barrel.

Oil futures rose on Thursday, driven by reports of an unscheduled shutdown of a US fuel pipeline. On the flip side, reports that Saudi Arabia has dropped the official selling price of its Arab Light to Asian markets due to demand worries as well as mounting recessionary concerns, limiting today's price rises.

In the commodities market, spot gold fell by \$21 to around \$1830 per ounce, owing to a dollar rally triggered by market reaction to a hawkish shift.
