## Domestic Equities Index Falls by 0.48% amid Renewed Bearish Activity; NITTY Falls for All Tenor Buckets on Buy Pressure...


At the end of Tuesday's trading session, the equities market moderated by 0.48% to settle at 51,446.60 points amid renewed profit-taking activities despite the Exchange printing 18 gainers as against 16 losers at the close of the trading session. Hence, the year-to-date gain of the NGX ASI dropped to 0.38%. Particularly, the NGX Insurance Index took the most hit, dropping by 1.75 percent on declines in shares of NEM (-10.00%) and CORNERST (-6.67%). Similarly, the NGX Consumer Goods Index waned by 0.23%, driven by losses in CHAMPIONS (-9.58%), and HONEYFLOUR (-4.96%) stocks. On the positive side, the NGX Banking and Industrial indexes climbed by 0.07% and 1.54%, respectively, as investors increased their holdings in DANGCEM (+3.05%), WEMABANK (+1.96), FCMB (+0.27%), and ZENITHBANK (+0.21%). The NGX Oil/Gas Index held steady from the previous day. Meanwhile, trading activity remained upbeat, with total deals, volume, and value increasing by 7.28%, 50.73%, and 185.11%, respectively, to 4,184 trades, 345.49 million units, and N8.29 billion. In terms of volume, FBNH was the most active stock, with 151.39 million shares worth N1.70 billion changing hands in 175 deals.



## Money Market

NIBOR moved in mixed directions, although short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), decreased further to 9.5% (down from 10.17%) and 9.83% (down from 10.83%), respectively.

Meanwhile, NITTY fell across the board for all of the tenor buckets tracked, even as the average secondary market T-bill yield fell to 2.93% amid buy interest, particularly on Mar 30 2023 (-78 bps), Apr 13 2023 (-64 bps), and Apr 17 2023 (-48 bps) T-bills.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for most maturities monitored. In contrast, the average secondary market yield rose by 5 bps to 12.76%. Specifically, the yield on 30-year debt increased by 294 bps (2.94%) to 14.57%. Meanwhile, the yields on the 10-year, 15-year, and 20-year bonds stayed steady at 12.59%, 13.50%, and 14.77%, respectively.

Elsewhere, the value of the FGN Eurobond increased for the bulk of the maturities tracked amid sustained bullish sentiment. Consequently, the average secondary market yield declined by 4 bps to 10.95%.

## Foreign Exchange Market

In FX, The Naira appreciated against the US dollar at the I&E windows, rising 0.04% to N461.50 (from N461.67). Furthermore, the parallel market rate gained 0.13% to N742 from N743.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 0.56% to \$80.1 a barrel. Similarly, WTI crude oil rose 0.65% to \$75.12 per barrel.

On Tuesday, oil prices remained stable at around \$80 per barrel as investors remained cautious about taking positions ahead of the US Fed Chair Speech and the US CPI report on Thursday.

Spot gold gained roughly \$5 to trade near \$1876 per ounce amid a weakening dollar.
