## NGX All-Share Index Moderates by 16 bps amid Renewed Profit-Taking Activities; NIBOR Falls for Most Tenor Buckets on Sustained Liquidity Ease.


The local equities market All-Share index fell by 0.16% to close at 52,615.51 points as investors were mostly bearish on the shares of OANDO (3.51%), DANGSUGAR (2.00%), DANGCEM (1.85%), STERLNBANK (1.30%), and WAPCO (1.01%). On the positive side, shares of JAPPAULGOLD, UBA, GTCO, AIRTELAFRI, and ACCESSCORP were investors' toast today, leading to their respective prices rising by 3.33%, 1.24%, 1.03%, 0.63%, and 0.56%. Given the significant pressure from bears (21 stocks) versus bulls (17 stocks), the index's year-to-date gain slipped to 2.66%. Despite the renewed bearish market, most of the sub-sector gauges moved northward. The NGX Banking, NGX Insurance, and NGX Oil/Gas indices rose by 0.05%, 1.36%, and 0.07%, respectively. However, the NGX Consumer Goods index and the NGX Industrial index fell by 0.20% and 0.99%, respectively. In the broader market, NGX Premium and NGX-30 lost 0.68% and 0.19%, respectively. Meanwhile, trading activity was downbeat, with total deals and volume decreasing by 8.26% and 4.61%, respectively, to 3,377 trades, and 217.95 million units. In terms of volume, STERLNBANK was the most active stock, with 94.27 million shares worth N145.52 million changing hands in 38 deals.



## Money Market

NIBOR fell across the board for most maturities tracked, likewise, other measures of money market stress eased further, as banks with liquidity sought lower rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), remained unchanged at 9.50% and 9.83%, respectively.

Meanwhile, NITTY decreased for the bulk of tenor buckets tracked, despite the average secondary market yield on T-bills expanding to 3.29% (from 3.27%).

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained largely flat for most maturities monitored. In contrast, the average secondary market yield expanded by 4 basis points to 12.97%. Specifically, the yield on the 20-year paper increased by 30 bps (0.30%) to 15.05%. Meanwhile, the yields on the 10-year, 15-year, and 30-year bonds stayed steady at 13.90%, 13.50%, and 14.90%, respectively.

Elsewhere, the value of the FGN Eurobond increased for all of the maturities tracked amid renewed bullish sentiment. Consequently, the average secondary market yield decreased by 26 bps to 10.25%.

## Foreign Exchange Market

In FX, the Naira appreciated against the US dollar at the I&E windows, rising 0.05% to ₦461.25 (from ₦461.50). Conversely, the parallel market rate lost 0.67% to ₦747 from ₦742.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 1.60% to \$87.30 a barrel. Similarly, WTI crude oil rose 2.15% to \$81.91 per barrel.

Oil futures traded higher on Wednesday, lifted by the prospect of improved global energy demand as China reopens its economy.

Spot gold rose by \$15.08 to about \$1923 per ounce, boosted by losses in the US dollar and treasuries as well as a disappointing US retail sales report (-1.1% m/m).
