Local Equities Market Index Rises by 93 bps as AIRTELAFRI Accounts for 43% of Transactions Today; NIBOR Falls for All Maturities on Liquidity Boost...

The domestic bourse index advanced by 0.93% to settle at 53,998.12 points, as investors continue to digest a flurry of full-year corporate earnings. Accordingly, the year-to-date performance of the index climbed to 5.36%, even as the Exchange printed a higher number of gainers (27) than losers (12). Oil stocks, MRS (+10.00%) and SEPLAT (+9.50%), in particular, led to today's gain, bolstered by strong investor patronage, as the NGX Oil/Gas index revved up by 5.17%. Additionally, FCMB (+6.82%), GEREGU (+4.29%), and MTNN (+3.78%) finished higher as investors reacted positively to their strong corporate results and dividends. Sectorial performance was mixed, with the NGX Banking and NGX Insurance Indices declining by 0.44% and 0.39%, respectively; while the NGX Consumer Goods Indices and the NGX Industrial Indices stayed flat from the previous trading day. In the broader market, the NGX Premium and the NGX-30 index increased by 195 basis points and 91 basis points, respectively. Meanwhile, trading activity ballooned, with total deals, volume, and value rising by 6.03%, 1331.88%, and 46.08%, respectively, to 3,940 trades, 2.87 billion units, and N8.07 billion. In terms of volume, UNIVINSURE was the most active stock, with 2.72 billion shares worth N543.21 million changing hands in 8 deals.







## Money Market

NIBOR fell across the board for all maturities tracked, as gauges of money market stress eased and banks with liquidity sought lower rates. On the other hand, short-term benchmark rates moved in a mixed direction, as the open repo rate (OPR) stayed stable at 10.50% while the overnight lending rate (OVN) fell to 10.75%.

Meanwhile, NITTY fell across the board for the majority of the tenor buckets tracked, despite the average secondary market yield on T-bills rising to 1.59% amid sell pressure, particularly on the Nov 09, 2023, T-bill.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the bulk of maturities examined. However, the average secondary market yield contracted by 5 basis points to 13.19%. Specifically, the 20-year note was richer by 132 basis points as its corresponding yield fell to 15.60% (from 15.80%). Notably, the yields on the 10-year, 15-year, and 30-year bonds stayed stable at 13.36%, 14.58%, and 14.96%, respectively.

Elsewhere, the value of the FGN Eurobond increased for most of the maturities amid sustained bullish sentiment. Notably, the average secondary market yield compressed to 11.49%.

## Foreign Exchange Market

The Naira weakened against the greenback, trading at N462 at the I&E windows. Likewise, the parallel market depreciated by 0.80% to N755 from N749.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 0.46% to \$82.46 a barrel. Similarly, WTI crude oil fell 0.67% to \$75.9 per barrel.

Oil prices declined on Thursday, weighed down by a larger-than-expected increase in US oil stockpiles (4.14 million barrels vs. Exp. 3.764 million barrels) and increased Russian crude shipments.

Spot gold was trading around \$1938 per ounce (down 0.61%) despite dovish remarks by the US Fed Chair, Jerome Powell, which pushed the dollar lower.
