


## Bullish Sentiment Persists in the Equities Market as NGX-ASI Gains 0.24%, NIBOR Rises for All Tenor Buckets on Sustained Liquidity Squeeze...

The local bourse All-Share index rose further by 0.24% to close at 54,496.31 points. Hence, the year-to-date gain of the index rose to 6.33% despite the exchange printing a higher number of losers (19) than gainers (17). On the positive side, the share price of TRIPPLEG increased by 9.49%, followed by COURTVILLE (+8.33%), CHAMS (+6.90%), GUINNESS (+6.35%), and PRESTIGE (+5.00%) amid sustained bargain hunting activity. Despite the bullish sentiment, performance across the sub-sector was a mixed bag as the NGX Banking and NGX Insurance indices fell by 0.53% and 0.23%, respectively, while the NGX Consumer Goods and NGX Industrial indices advanced by 0.41%, and 0.04%, respectively. The NGX Oil/Gas remained unchanged. In the broader market, the NGX Premium and the NGX-30 index increased by 52 basis points and 23 basis points, respectively. Meanwhile, trading activity increased, with total deals, volume, and value rising by 1.80%, 26.33%, and 80.23%, respectively, to 3,617 trades, 177.92 million units, and N5.69 billion. In terms of volume, BUAFOODS was the most active stock, with 50.01 million shares worth N3.72 billion changing hands in 34 deals.



## Money Market

NIBOR rose across the board for all maturities tracked, as gauges of money market stress tightened further and banks with liquidity requested high rates. Likewise, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), increased to 10.75% (from 10.50%) and 11.20% (from 10.81%), respectively.

Meanwhile, NITTY fell across the board for most tenor buckets monitored, despite the average secondary market yield on T-bills rising to 1.62% due to sell pressure on the 9 Mar 2023 and 30 Mar 2023 T-bills.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained largely flat for the majority of maturities examined. However, the average secondary market yield increased by 5 basis points to 13.11%. The 30-year debt was 1 bps cheaper, with yields rising to 15.26% (from 15.25%). Notably, the 10-year, 15-year, and 20-year debt yields remained constant at 13.10%, 14.79%, and 15.80%, respectively.

Elsewhere, the value of the FGN Eurobond increased for all of the maturities amid sustained bullish sentiment. Notably, the average secondary market yield contracted marginally to 12.20%.

## Foreign Exchange Market

The Naira weakened against the greenback, exchanging at N461.67 at the I&E windows. Similarly, the parallel market depreciated by 0.26% to N758 from N756.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 2.57% to \$84.39 a barrel. Similarly, WTI crude fell 2.63% to \$78.03 per barrel.

Oil prices fell on Tuesday as market sentiment turned gloomy following the US government's announcement that it intends to release 26 million barrels from its strategic reserves.

Gold was trading around \$1855 per ounce (up 0.09%), supported by a retracement in the US dollar and treasuries as the US CPI reading for January rose by 0.5% in line with expectations.
