Gains in GEREGU and GTCO shares lift the NGX Index by 0.23%; NITTY Rises for All Maturities Tracked on Sustained Sell Pressure...

The local bourse returned bullish as the NGX All Share Index advanced by 0.23% to close at 54,315.53 points. Consequently, the year-to-date performance of the index increased to 5.98% even as the Exchange printed a higher number of gainers (18) than losers (11). Specifically, the share prices of tickers such as GEREGU, TRANSCORP, FCMB, GTCO, and ZENITHBANK rose by 10.00%, 4.20%, 1.16%, 0.80%, and 0.80%, respectively, amid buy pressure. Performance across sub-sector gauges was positive, as the NGX Banking and NGX Consumer Goods indices rose by 0.25% and 0.01%, respectively. On the flip side, the NGX Insurance Index lost 0.79%, while the NGX Oil/Gas and the NGX Industrial indices stayed unchanged from the previous days. In the broader market, the NGX Premium and NGX-30 indices increased by 5 and 9 basis points, respectively. Meanwhile, trading activity decreased, with total deals, volume, and value falling by 9.22%, 48.89%, and 74.82%, respectively, to 2,678 trades, 129.91 million units, and N3.92 billion. In terms of volume, AIICO was the most active stock, with 16.18 million shares worth N9.62 million changing hands in 66 deals.







Money Market

NIBOR fell across the board for all maturities tracked, as gauges of money market stress eased and banks with liquidity sought lower rates. Likewise, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), crashed to 11.88% (from 16.50%) and 12.56% (from 16.94%), respectively.

Meanwhile, NITTY rose across the board for all of the tenor buckets monitored, despite the average secondary market yield on T-bills contracting to 4.05%.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds were largely flat for the bulk of the maturities examined. Similarly, the average secondary market yield stayed steady at 13.24%. The 20-year was 8 basis points richer, with its corresponding yield falling to 15.80% (from 15.88%). Notably, 10-year, 15-year, and 30-year debt yields remained stable at 13.10%, 14.80%, and 15.20%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for all of the maturities amid renewed bearish sentiment. Notably, the average secondary market yield increased to 12.54%.

Foreign Exchange Market

The Naira weakened against the greenback, exchanging at N461.6 (from N461.33) at the I&E windows. Similarly, the parallel market depreciated by 0.26% to N767 from N765.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 0.75% to \$83.44 a barrel. Similarly, WTI crude fell 0.03% to \$77.21 per barrel.

On Wednesday, oil futures declined as optimism over China's recovery was tempered by declining energy demand and expectations for a global economic slowdown.

Gold was trading below \$1840 per ounce (up +0.16%), fueled by a fall in the US Treasury yield ahead of today's FOMC minutes.
