





Nigerian Stock Market Index Rises by 0.49% amid Gains on TRANSCORP, ACCESSCORP Shares; NITTY Falls for All Maturities Tracked amid Buy Pressure...

The local bourse index rose by 0.49% with a gain of 0.69% year-to-date to close at 51,606.49 points, even as the exchange printed a higher number of gainers (33) than losers (9). TRANSCORP (+9.80%), ACCESSCORP (+7.07%), STANBIC (+3.93%), OANDO (+2.34%), and MTNN (+2.23%) closed higher, while WAPIC (-7.32%), AIICO (-3.64%), FIDELITYBK (-2.93%), and ETI (-0.45%) closed negative. Performance across sub-indices was largely positive, as four of the five sector gauges tracked gained. The NGX Banking, NGX Insurance, NGX Consumer Goods, and NGX Industrial indexes fell by 1.30%, 0.07%, 0.37%, and 0.11%, respectively. Meanwhile, trading activity improved, with total deals, volume, and value increasing by 48.62%, 247.90%, and 75.08%, respectively, to 6,404 trades, 2.09 billion units, and N8.85 billion. In terms of volume, TRANSCORP emerged as the most actively traded stock, with 1.66 billion shares worth N4.09 billion changing hands in 134 deals.



Money Market

NIBOR crashed across the board for all maturities tracked as gauges of money market stress eased and banks with liquidity sought lower rates. Short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), dipped to 14.63% (from 18.63%) and 15.25% (from 19.00%), respectively.

Meanwhile, NITTY fell for the bulk of tenor buckets amid buy interest. However, the average secondary market yield on T-bills remained unchanged at 8.79%.

Bond Market

In the OTC bond market, the value of plain-vanilla FGN bonds was largely flat for the bulk of maturities tracked, even as the average yield on the secondary market contracted to 13.82%. The 30-year debt was 127 basis points richer, while its corresponding yield fell to 15.49% (from 15.69%) Notably, the 10-year, 15-year, and 20-year yields remained steady at 13.48%, 14.75%, and 15.33%, respectively.

Elsewhere, the value of the FGN Eurobond traded higher for most of the maturities tracked amid renewed bullish sentiment. Similarly, the average secondary market yield compressed to 13.14%.

Foreign Exchange Market

The Naira strengthened against the greenback, trading higher at N463.44 (from N463.67) at the Investors and Exporters (I&E) windows. In contrast, the parallel market depreciated by 0.41% to N741 (from N738).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude fell 2.67% to \$80.52 per barrel, while WTI crude lost 2.56% to \$76.75 per barrel.

Oil futures declined on Tuesday as a stronger dollar and recession fears outweighed optimism around China's growth.

Gold was trading around \$1985 per ounce (-0.15%), under pressure from a firmer US dollar.
