




Domestic Equities Market Index Sheds 0.20% amid Renewed Bearish Activity; NIBOR Rises for All Tenor Buckets on Liquidity Squeeze...

At the end of Tuesday's trade, the domestic stock market index moderated by 0.20% to settle at 54,296.48 points amid profit taking activity, despite the Exchange recording more gainers (30) than losers (23). Consequently, the year-to-date gain of the NGX ASI rose to 2.04%. Specifically, investors sold part of their holdings in tickers such as GEREKU, TRANSCORP, INTBREW, PZ, and WAPCO; hence, their respective share prices fell by 10.00%, 9.96%, 8.51%, 6.56%, and 1.66%, respectively. Sectorial performance was positive, as four of the five indices tracked closed in green; the NGX Banking, NGX Insurance, NGX Consumer Goods, and NGX Oil/Gas indices rose by 2.84%, 1.25%, 0.31%, and 1.05%, respectively. On the flip side, the NGX Industrial Index dwindled by 0.08%. Meanwhile, trading activity nosedived, with total volume and value decreasing by 82.41% and 60.59%, respectively, to 550.29 million units and N5.15 billion. In terms of volume, ACCESSCORP emerged as the most actively traded stock, with 150 million shares worth N1.57 billion changing hands in 330 deals.



Money Market

NIBOR rose across the board for most maturities tracked as gauges of money market stress tightened and banks with liquidity sought higher rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), moderated to 11.00% (from 12.63%) and 11.38% (from 13.13%), respectively.

Meanwhile, NITTY rose for most tracked tenor buckets. However, the average secondary market yield on T-bills remained unchanged at 7.30%.

Bond Market

In the OTC bond market, the value of plain vanilla FGN bonds was steady for the bulk of maturities, even as the average yield on the secondary market contracted to 14.10%. The 10-year, 15-year, 20-year, and 30-year yields remained stable at 12.85%, 14.75%, 15.23%, and 15.46%, respectively.

Elsewhere, the value of the FGN Eurobond traded lower for most of the maturities tracked amid renewed bearish sentiment. Similarly, the average secondary market yield expanded to 12.94%.

Foreign Exchange Market

The Naira strengthened against the greenback, trading higher at N462.3 (from N463) at the Investors and Exporters (I&E) windows. Likewise, the parallel market appreciated by 0.14% to N738 (from N739).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude was down 3.34% to \$76.66 per barrel, while WTI crude lost 3.89% to \$72.72 per barrel.

Oil futures crashed on Tuesday amid disappointing Chinese economic data and increasing rate hike expectations.

Gold was trading above \$2004 per ounce (+1.19%), supported by a downtick in US Treasury yields as uncertainty around the health of the US banking system builds up after the acquisition of First Republic Bank by JP Morgan.
