




# Cowry Daily Market Insight 15 May 2023

NGX ASI Increases by 3 bps amid Bargain Hunting on OANDO, TRANSCORP, ACCESSCORP Shares; NIBOR Rises for All Tenor Buckets on Financial Liquidity Strain...

The Local Bourse Index rose by 0.03% with a gain of 1.91% year-to-date to close at 52,231.29 points, despite data from the National Bureau of Statistics (NBS) showing a 4th consecutive rise in inflation rate to 22.22% (previously 22.04%). Also, the Exchange printed a higher number of gainers (24) than losers (19) as OANDO, TRANSCORP, NAHCO, UBA, ACCESSCORP, and ZENITHBANK rallied by 9.91%, 9.65%, 6.61%, 1.82%, 1.01%, and 0.63%, respectively. On the flip side, PRESCO (-1.99%), GTCO (-0.62%), FBNH (-0.41%), and STANBIC (-0.27%) closed negative. Performance across sub-indices varied as the NGX Banking and the NGX Insurance indexes moderated by 0.02% and 1.41%, respectively, while the NGX Consumer Goods and the NGX Industrial Indices advanced by 0.03% and 0.02%, respectively. The NGX Oil/ Gas index remained unchanged from the previous day. Meanwhile, market activity improved, with total volume, and value decreasing by 55.81%, and 49.01%, respectively, to 626 million units and N5.60 billion. In terms of volume, TRANSCORP emerged as the most actively traded stock, with 190.85 million shares worth N530.82 million changing hands in 929 deals.





## Money Market

NIBOR increased across the board for all maturities tracked as gauges of money market stress tightened and banks with liquidity demanded higher rates. Short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), expanded to 13.13% (from 12.13%), and 13.88% (from 12.63%), respectively. Specifically, the three-month NIBOR rate further increased by 2 basis points to close at 15.65% amid the liquidity drain arising from today's FGN bond auction and Friday's CRR debit.

Meanwhile, NITTY rose for all tracked tenor buckets despite the average secondary market yield on T-bills staying flat at 6.65%.

## Bond Market

In the OTC bond market, the value of plain vanilla FGN bonds was largely flat for most maturities, even as the average yield on the secondary market remained unchanged at 14.00%. The 10-year, 15-year, 20-year, and 30-year yields held steady at 12.72%, 14.96%, 15.23%, and 15.83%, respectively.

Elsewhere, the value of the FGN Eurobond cleared higher for most of the maturities tracked on sustained bearish sentiment; consequently, the average secondary market yield contracted to 13.15%.

## Foreign Exchange Market

The Naira weakened against the greenback, trading lower at N464 (from N462.33) at the Investors and Exporters (I&E) windows. Similarly, the parallel market depreciated by 0.20% to N746 (from N745).

## Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.82% to \$74.61 per barrel, while WTI crude gained 0.82% to \$70.61 per barrel.

Oil futures rose on Monday as supply constraints edged out economic and energy demand concerns in the US and China.

Elsewhere, gold was trading near \$2,015 per ounce (+0.23%) as stalling US debt ceiling negotiations boosted appetite for non-yielding bullion.
