## Domestic Equities Market Index Rebounds by 0.29%; NIBOR Rises for All Tenor Buckets amid Renewed Liquidity Strain...

The domestic stock market index rose by 0.29% to settle at 52,973.88 points amid renewed bargain hunting. Consequently, the year-to-date gain of the local bourse inched upwards to 3.36% even as the total number of gainers (42) outweighed that of losers (11). Notably, the share price of BUACEMENT fell by 2.22%; however, this was neutralized by buy pressure on mid- and large-cap stocks such as CONOIL (+9.98%), UBA (+6.29%), and ACCESSCORP (+3.64%). Performance amongst the sector gauges showed that general market sentiment is positive, as four of the five sub-gauges closed in the green: the NGX Banking, NGX Insurance, NGX Consumer Goods, and the NGX Oil/Gas indexes rose by 2.14%, 2.40%, 0.41%, and 1.05%, respectively. On the downside, the NGX Industrial index fell by 0.88%. Meanwhile, market activity improved, with total deals, and volume increasing by 10.90%, and 22.44%, respectively, to 6,520 trades, and 461.78 million units. In terms of volume, UBA emerged as the most actively traded stock, with 59.41 million shares worth N529.10 million changing hands in 591 deals.





## Money Market

NIBOR increased across the board for all maturities tracked as gauges of money market stress tightened and banks with liquidity demanded higher rates. Likewise, short-term benchmark rates, such as the open repo rate (OPR), and the overnight lending rate (OVN), climbed, respectively, to 12.75% (from 11.25%) and 13.25% (from 11.50%). Specifically, the three-month NIBOR rate rose by 179 basis points to close at 11.68%.

Meanwhile, NITTY traded higher for most tracked tenor buckets despite the average secondary market yield on T-bills closing flat at 6.80%.

## Bond Market

In the OTC bond space, the value of plain vanilla FGN bonds was largely stable for most maturities, even as the average yield on the secondary market closed unchanged at 13.98%. The 10-year, 15-year, 20-year, and 30-year yields held steady at 12.55%, 14.81%, 15.58%, and 15.66%, respectively.

Elsewhere, the value of the FGN Eurobond closed lower for most of the maturities amid renewed bearish sentiment; however, the average secondary market yield decreased to 12.07%.

## Foreign Exchange Market

The Naira weakened against the US dollar, trading at N464.51 (from N463.67) at the Investors and Exporters (I&E) windows. Conversely, the parallel market experienced an appreciation, with a rise of 0.43% to N767 (from N770).

## Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 1.03% to \$77.05 per barrel, while WTI crude gained 1.12% to \$72.63 per barrel.

Oil futures rebounded on Friday as traders positioned ahead of the US debt deadline and the upcoming OPEC+ meeting.

Elsewhere, gold was trading near \$1,942 per ounce (+0.09%), hampered by a hotter-than-expected US Personal Consumption Expenditures (PCE) Index, which raised interest rate hikes while pushing the dollar downwards.
