## Domestic Equities Rebound by 1.33% amid Renewed Bullish Activity; NIBOR Rises for All Tenor Buckets amid Renewed Liquidity Strain...

At the end of Wednesday's trade, the local bourse clawed back some of yesterday's losses following buying interest in mid- and large-cap stocks; hence, the NGX ASI gained 1.33% to settle at 61,523.57 points. Consequently, the year-to-date gain of the NGX ASI rose to 20.04%; despite the bulls (43) outnumbering the bears (30). Specifically, BUACEMENT, PRESCO, CONOIL, ACCESSCORP, FBNH, UBA, WAPCO, GTCO, and ZENITHBANK were the toast of investors today as their share prices rose by 9.44%, 7.73%, 5.68%, 4.37%, 3.35%, 2.75%, 2.59%, 2.56%, and 0.59%, respectively. Breakdown across sub-sector gauges tracked indicated that three out of the five indices tracked closed in green: the NGX Banking, NGX Oil/Gas, NGX Consumer Goods, and the NGX Industrial indices rose by 1.89%, 0.07%, 0.18%, and 3.86%, respectively. However, the NGX Insurance index moderated by 4.68%. Meanwhile, market activity nosedived, with total deals, volume, and value decreasing by 19.51%, 23.57%, and 15.59%, respectively, to 9,815 trades, N846.32 million units, and N10.31 billion. In terms of volume, FBNH emerged as the most actively traded stock, with 89.24 million shares worth N1.65 billion changing hands in 337 deals.





## Money Market

In the interbank space, the Nigeria Inter-Bank Offered Rate (NIBOR) increased across all tenor buckets due to tightened liquidity conditions. The three-month NIBOR rate closed higher by 47 basis points (bps) at 8.65%. However, key money market rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), declined to 0.83% (from 1.14%) and 1.15% (from 1.57%), respectively.

Meanwhile, NITTY rose for most maturities tracked due to selling pressure. Conversely, the average secondary market yield on T-bills moderated to 6.25%.

## Bond Market

In the bond space, the values of the FGN bonds remained unchanged from the last close. However, losses across short-dated bonds, particularly the 17 MAR 2027 paper (cheaper by 126 bps), drove the average secondary market yield higher to 12.52%. Notably, the 30-year borrowing cost yielded around 14.47% (from 14.69%), while the 10-year and 20-year notes remained stable at 12.82% and 14.60%, respectively.

Elsewhere, FGN Eurobonds depreciated for all maturities tracked on renewed bearish activity. Likewise, the average secondary market yield expanded to 13.91%.

## Foreign Exchange Market

In FX, the Naira strengthened against the US dollar at the Investors and Exporters (I&E) windows, trading at N742.31 (from N768.44). However, the parallel market experienced a depreciation, with the Naira falling 0.76% to N780.9 (from N775).

## Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.42% to \$76.57 per barrel, while WTI crude gained 1.11% to \$71.94 per barrel.

Oil futures rose slightly on Tuesday, riven by proposed output cuts from two major exporters, Saudi Arabia and Russia.

Elsewhere, gold was a little unchanged at \$1,925 per ounce (+0.02%) as traders awaited the release of the June FOMC minutes.
