Local Bourse Continues Bullish Sentiment as NGX All Share Index Rises Further by 1.65%; NIBOR Increases for All Tenor Buckets on Liquidity Strain...

The domestic bourse continued its upward trend, with the NGX All Share Index (ASI) rising further by 1.65%. Consequently, the year-to-date performance of the index remained in double-digit territory at 23.00%, even as the Exchange printed a higher number of gainers (66) than losers (12), as the bulls remained in control. Specifically, share prices of tickers such as PRESCO, FIDELITYBK, ETERNA, TRANSCORP, MRS, UBA, and DANGCEM gained by 10.00%, 9.98%, 9.86%, 9.84%, 8.98%, 6.37%, and 3.48%, respectively, amid sustained investors' confidence. Furthermore, performance by sub-sector index reflected bullish sentiment as the NGX Banking, NGX Insurance, NGX Consumer Goods, NGX Oil/Gas, and NGX Industrial Indexes gained 3.33%, 4.89%, 0.32%, 1.06%, and 1.81%, respectively. Meanwhile, market activity mellowed, with total volume, and value decreasing by 77.45%, and 85.42%, respectively, to N1.23 billion units and N13.85 billion. In terms of volume, FBNH emerged as the most actively traded stock, with 131.77 million shares worth N2.63 billion changing hands in 352 deals.





Money Market

The Nigeria Inter-Bank Offered Rate (NIBOR) increased across most tenor buckets in the interbank space due to tighter liquidity conditions. The three-month NIBOR rate remained unchanged at 8.65%, while key money market rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), moderated slightly to 0.86% (from 0.93%) and 1.25% (from 1.29%), respectively.

Meanwhile, NITTY rose for most maturities tracked due to selling pressure. Similarly, the average secondary market yield on T-bills increased to 6.52%.

Bond Market

In the bond space, the values of the FGN bonds remained unchanged from the last close for the bulk of the maturities tracked. However, losses at the short and mid-end, particularly the 23 FEB 2028 paper, led to an expansion in the average secondary market yield to 12.46%. Notably, the 20-year borrowing cost yielded around 14.30% (from 14.60%), while the 10-year and 30-year notes held steady at 12.82% and 14.55%, respectively.

Elsewhere, FGN Eurobonds depreciated for all maturities tracked on sustained bearish activity. Likewise, the average secondary market yield expanded to 33.33%.

Foreign Exchange Market

In FX, the Naira weakened further against the US dollar at the Investors and Exporters (I&E) windows, trading at N776.90 (from N762.63). Likewise, the parallel market experienced a depreciation, with the Naira falling 0.75% to N792.2 (from N786).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 1.63% to \$77.76 per barrel, while WTI crude gained 1.58% to \$72.93 per barrel.

Oil futures fell on Friday, spurred by supply constraints despite concerns about interest rate hikes and demand.

Elsewhere, gold was trading above \$1,930 per ounce (+1.02%), driven by soft US nonfarm payrolls (actual: 209k, consensus: 240k), which reduced rate hike expectations, pushing US Treasury yields lower.
