Nigerian Equities Market Sustains Bullish Trend as ASI Rises by 1.31%; NIBOR Moves Northwards for All Tenor Buckets on Bearish Activity...

The local equities market All-Share Index (ASI) rose by 1.31% to comfortably climb to 63,766.72 points level as investors continued to lock in their monies in quoted companies. Hence, the number of gainers (50) exceeded that of the losers (23) today, pushing, the year-to-date gain of the local bourse to 24.42%. Notable performers included ETERNA (+9.92%), PZ (+9.88%), TRANSCORP (+9.70%), DANGCEM (+6.67%), NB (+2.70%), and GTCO (+1.47%). Sub-sector gauges were largely bullish as the NGX Insurance, NGX Consumer Goods, NGX Oil/Gas, and the NGX Industrial indices increased by 4.25%, 0.66%, 0.56%, and 3.58% respectively. On the flip side, the NGX Insurance index moderated by 0.17%. Meanwhile, market activity improved, with total deals, volume, and value increasing by 18.24%, 56.66%, and 0.60%, respectively, to 8,979 trades, 710.02 million units, and N13.83 billion. In terms of volume, FCMB emerged as the most actively traded stock, with 153.88 million shares worth N956.07 million changing hands in 420 deals.







## Money Market

The Nigeria Inter-Bank Offered Rate (NIBOR) increased across most tenor buckets in the interbank space due to tighter liquidity conditions. The three-month NIBOR rate rose by 419 basis points to 11.71%. Likewise, key money market rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), increased to 2.71% (from 1.04%) and 3.42% (from 1.42%), respectively.

Meanwhile, NITTY moderated for most tenor buckets amid sustained bullish sentiment. Conversely, the average secondary market yield on T-bills stayed unchanged at 6.25%.

## Bond Market

In the OTC bond market, the value of FGN bonds mostly remained stable across various maturities. However, short and long-dated bonds, notably the 23 MAR 2025 bond, experienced gains, resulting in a further contraction in the average secondary market yield to 12.2% (from 12.25%). The 30-year borrowing cost yielded around 14.12% (down from 14.30%), while the 10-year and 20-year papers remained steady at 12.75% and 14.35% respectively.

Conversely, FGN Eurobonds depreciated across all tracked tenors amid sustained bearish sentiment, leading to an expansion in the average secondary market yield to 10.36%.

## Foreign Exchange Market

In FX, the Naira strengthened against the US dollar at the Investors and Exporters (I&E) windows, trading at N742.93 (from N795.28). Conversely, the parallel market experienced further depreciation, with the Naira falling 0.61% to N830 (from N815).

## Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 1.33% to \$79.54 per barrel, while WTI crude gained 1.95% to \$75.60 per barrel.

Oil futures were higher on Tuesday, supported by an improved demand outlook as indicated by a drop in the US crude output.

Elsewhere, gold was trading near \$1,984 per ounce (+1.47%), boosted by lower US dollar and Treasury yields
