Domestic Equities Market Index Gains 1.10% amid Sustained Bargain Hunting Activity; NIBOR Rises for All Maturities amid Sell Pressure...

At the close of Tuesday's trading session, the domestic bourse remained resilient with investors taking more bets on the market amid expectations of the outcome of the MPC meeting and gained 1.10% to settle at 65,988.81 points, as investors hunted for bargains on blue-chip stocks. Concurrently, the year-to-date gain of the local bourse advanced to an impressive 28.76%, with 32 gainers outpacing 30 losers. Sectorial performance was mixed as three of the five indices tracked closed in the red zone: the NGX Insurance, NGX Consumer Goods, and NGX Industrial indices moderated by 6bps, 2bps, and 14bps, respectively, and on the flip side, the NGX Banking and NGX Oil/Gas indices rose by 0.45% and 3.25%. Meanwhile, market activity nosedived, with total deals, volume, and value decreasing by 14.90%, 33.43%, and 42.62%, respectively, amounting to 8,313 trades, 553.52 million units, and N7.42 billion. In terms of volume, JAPUALGOLD emerged as the most actively traded stock, with 72.49 million shares worth N73.21 billion changing hands in 178 deals.





Money Market

The Nigeria Inter-Bank Offered Rate (NIBOR) trended higher across all tenor buckets due to tighter liquidity conditions. Notably, the three-month NIBOR rate increased by 72 basis points to 13.00%. However, the open repo rate (OPR) and the overnight lending rate (OVN) experienced significant declines, falling to 14.00% (from 19.43%) and 14.86% (from 19.83%), respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) moved in mixed directions ahead of Wednesday's PMA.

Bond Market

In the Over-the-Counter (OTC) bond market, Federal Government of Nigeria (FGN) bonds traded largely flat across various maturities. However, mid-and long-dated bonds, particularly the 21 JUN 2053 debt, faced losses due to anticipated interest rate hikes at the Monetary Policy Committee (MPC) meeting. As a result, the average secondary market yield witnessed a slight expansion, rising to 12.22% from 12.20%. The 10-year borrowing cost also saw an increase, yielding approximately 12.95% compared to the previous figure of 12.87%. Conversely, the 20-year and 30-year bonds remained stable at 14.21% and 14.12%, respectively.

Elsewhere, FGN Eurobonds appreciated across most tracked tenors, reflecting sustained bullish sentiment, as the average secondary market yield contracted to 10.42% (from 10.47%).

Foreign Exchange Market

In FX, the Naira strengthened against the US dollar at the Investors and Exporters (I&E) windows, trading at N791.42 (from N792.04). Similarly, in the parallel market, the Naira appreciated by 0.91% to N867 against the US dollar.

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.41% to \$83.08 per barrel, while WTI crude gained 0.55% to \$79.17 per barrel.

Oil futures were higher on Tuesday as investors assessed the impact of potential supply disruptions in the near term and expected improvement in Chinese energy demand.

Elsewhere, gold was hovering around \$1,961 per ounce (0.37%), as investors positioned themselves ahead of the US Federal Reserve policy rate decision.
