Local Bourse Index Moderates by 0.31% amid Sustained Profit-Taking Activity on Bellwethers; NIBOR Moves Southwards for All Tenor Buckets on Liquidity Ease...

The NGX index fell by 31 basis points (bps) to close at 65,482.91 points amid profit-taking on high-cap stocks such as NB (-4.76%), FLOURMILL (-4.55%), FBNH (-4.39%), GTCO (-3.10%), and ZENITHBANK (-0.85%). Notably, investors decided to further shed their holdings in CADBURY (-9.80%) and UNILEVER (-1.59%) due to their disappointing H1 earnings. Hence, the year-to-date gain of the local bourse mellowed to 27.77% even as the number of gainers decreased to 14 as against that of losers, which stood at 38. Despite the negative market sentiment, three of the five indexes tracked closed in green: the NGX Banking, NGX Oil/Gas, and NGX Industrial rose by 0.02%, 0.88%, and 0.01%, respectively. However, the NGX Insurance and the NGX Consumer Goods indices rose by 0.95% and 0.66%, respectively. Meanwhile, market activity improved, with total deals and volume increasing by 9.87%, and 1.76%, respectively, amounting to 8,070 trades, and 509.25 million units. In terms of volume, JAPAUFGOLD emerged as the most actively traded stock, with 115.70 million shares worth N129.72 billion changing hands in 471 deals.





Money Market

The NIBOR rates across all tenor buckets declined, due to improved liquidity conditions resulting from FAAC inflows. Specifically, the three-month NIBOR rate decreased significantly by 221 basis points to 10.67%, reflecting eased credit conditions. Additionally, the open repo rate (OPR) and the overnight lending rate (OVN) both plummeted to 0.90% and 1.30%, respectively.

Meanwhile, the Nigerian Interbank Treasury Bills True Yield (NITTY) observed further upward movement across all maturities, driven by sell pressures from traders seeking higher yields. Concurrently, the average secondary market yield on T-bills rose to 7.12%.

Bond Market

In the OTC bond market, trading values for FGN bonds remained subdued amid a quiet market. However, the 14 MAR 2024 debt underperformed, leading to an expansion in the average secondary market yield to 12.60% (up from 12.41%). The 10-year, 20-year note and 30-year paper held steady at 12.99%, 14.60%, and 14.63%, respectively.

Elsewhere, FGN Eurobonds appreciated across all tracked maturities, reflecting sustained bullish sentiment, as the average secondary market yield contracted to 10.10% (from 10.35%).

Foreign Exchange Market

In FX, the Naira weakened against the US dollar at the Investors and Exporters (I&E) windows, trading at N768.60 (from N740.08). Conversely, in the parallel market, the Naira remained unchanged at N870 against the US dollar.

Global Commodity Market


At 3:30 p.m. GMT+1, Brent crude rose 1.02% to \$83.76 per barrel, while WTI crude gained 1.26% to \$79.77 per barrel.

Oil futures were higher on Thursday, driven by increased Chinese energy demand and expectations of tighter supply conditions.

Elsewhere, gold was trading near \$1,945 per ounce (-1.36%), fueled by improved investors risk appetite amid a stronger than expected US Q2 GDP (actual: +2.4%, consensus: +1.8%), as well as a softer US initial jobless claim (actual: 221K, consensus: 235K).
