



Nigerian Stock Exchange Index Falls by 0.65% as Bellwether Stocks Lose Grip; NIBOR Moderates for Most Maturities amid Financial Liquidity Boost...

The domestic stock exchange All-Share Index (ASI) declined by 0.65% to 65,056.39 points as investors took profit on bellwether shares, especially, WAPCO (-3.58%), ZENITHBANK (-2.86%), GTCO (-1.20%), and MTNN (-1.13%). Hence, the year-to-date gain of the local bourse moderated to 3.49% even as the exchange registered a higher number of losers (38) than gainers (21). Sectoral performance followed a bearish trend, with four out of five indices closing in negative territory. The NGX Banking, NGX Insurance, NGX Consumer Goods, and NGX Industrial indexes fell by 1.26%, 1.83%, 1.27%, and 0.19%, respectively. Meanwhile, the NGX Oil/Gas index remained unchanged. Market activity mellowed, with total deals and volume decreasing by 0.24%, and 9.72%, respectively, amounting to 8,051 trades, and 459.77 million units. In terms of volume, UBA emerged as the most actively traded stock, with 57.62 million shares worth N832.31 billion changing hands in 422 deals.



Money Market

The money market saw a decline in NIBOR rates across most tenor buckets due to sustained liquidity ease. Notably, the three-month NIBOR rate experienced a significant decrease of 367 basis points, falling to 7.00% from 10.67%. Key money market rates, such as the open repo rate (OPR), remained unchanged at 0.90%, while the overnight lending rate (OVN) rose slightly to 1.40% from 1.30%.

Meanwhile, the Nigerian Interbank Treasury Bills True Yield (NITTY) observed further upward movement across all maturities, driven by sell pressures from traders seeking higher yields. Conversely, the average secondary market yield on T-bills stayed flat at 7.12%.

Bond Market

In the OTC bond market, trading values for FGN bonds remained muted for most maturities. However, sell-offs, particularly on long-dated securities like the 21 JAN 2042 debt, resulted in a further expansion of the average secondary market yield to 12.70% from 12.60%. The 30-year borrowing cost also increased, yielding approximately 14.89% compared to the previous figure of 14.63%. Conversely, the 10-year and 20-year bonds remained stable at 12.99% and 14.60%, respectively.

Elsewhere, FGN Eurobonds depreciated across all tracked maturities, reflecting renewed bearish sentiment, as the average secondary market yield increased to 10.15% (from 10.10%).

Foreign Exchange Market

In the foreign exchange market, the Naira weakened against the US dollar at the Investors and Exporters (I&E) windows, trading at N775.76 compared to N768.60. However, in the parallel market, the Naira gained 0.34% against the US dollar, reaching N867.


Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 1.02% to \$83.76 per barrel, while WTI crude gained 1.26% to \$79.77 per barrel.

Oil futures were higher on Friday, as optimism surrounding global energy demand coupled with expectations of further supply cuts weighed on the market.

Elsewhere, gold was trading near \$1,960 per ounce (-1.36%), as softer US June PCE inflation (actual: 4.1%, consensus: 4.2%) raised expectations for a pause in policy rate hikes, leading to a retracement in the US dollar.
