Local Bourse Index Moderates by 0.23% amid Sustained Profit-Taking Activity; NIBOR Rises for all Maturities Tracked on Financial System Liquidity Squeeze...

The domestic stock market index further nosedived by 0.23% to close at 64,192.20 points as the bear's sustained dominance at the close of trading. Hence, the year-to-date gain of the local bourse moderated to 25.25%. Likewise, the Exchange printed a lower number of gainers (22) than losers (37). Specifically, the share prices of FIDELITYBK, GUINNESS, GTCO, ACCESSCORP, and ZENITHBANK declined by 9.88%, 8.26%, 3.14%, 2.35%, and 1.18%, respectively. Sectorial performance was a mixed bag, with the NGX Insurance and NGX Consumer Goods indices rising by 0.95% and 0.54%, respectively. Conversely, NGX Industrial and NGX Oil/Gas remained flat, while NGX Banking emerged as the sole gainer with a 1.94% increase. Meanwhile, market activity improved, with total volume and value increasing by 13.17% and 19.09%, respectively, amounting to 762.10 million units, and N7.71 billion. In terms of volume, AICO emerged as the most actively traded stock, with 314.64 million shares worth N220.21 million changing hands in 82 deals.





Money Market

The Nigeria Inter-Bank Offered Rate (NIBOR) rose across all tenor buckets due to tight liquidity conditions. Notably, the three-month NIBOR rate experienced a significant increase of 327 basis points, climbing to 14.70% (from 11.43%). Key money market rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), climbed to 2.21% (from 0.92%) and 2.57% (from 1.42%).

Meanwhile, the Nigerian Interbank Treasury Bills True Yield (NITTY) observed further upward movement across most maturities, driven by profit-taking from traders seeking higher yields. Conversely, the average secondary market yield on T-bills remained at 7.12%.

Bond Market

In the OTC bond market, FGN bonds were muted for most maturities tracked. Sell interest, particularly in the 27 MAR 2050 debt, led to a contraction in the average secondary market yield to 14.96% (from 14.82%). The 10-year and 20-year bonds held steady at 12.90% and 14.60%, respectively.

Elsewhere, FGN Eurobonds depreciated across all tracked maturities, reflecting renewed bearish sentiment, as the average secondary market yield increased to 10.07% (from 10.00%).

Foreign Exchange Market

In the foreign exchange market, the Naira weakened against the US dollar at the Investors and Exporters (I&E) windows, trading at N789.08 compared to N756.94. Similarly, in the parallel market, the Naira lost 0.23% against the US dollar, reaching N872.

Global Commodity Market


At 3:30 p.m. GMT+1, Brent crude rose 0.89% to \$84.67 per barrel, while WTI crude lost 1.06% to \$80.93 per barrel.

Oil futures were lower on Tuesday as expectations for further tight global supply outweighed demand concerns stemming from mixed Chinese PMI data (PMI: 49.3, consensus: 49.2, previous: 49.0).

Elsewhere, gold was trading near \$1,945 per ounce (-0.94%), as expectations for a pause in the policy rate, pushed US Treasury yields.
