Domestic Equities Market Rebounds as NGX ASI Rises by 0.24%; NITTY Falls for All Tenor Buckets on Demand Pressure...

The local bourse closed the week on a positive note as its All-share index advanced by 0.24% to close at 65,558.91 points, even as the number of gainers (31) outweighed that of losers (23). Consequently, the year-to-date gain of the local bourse climbed to 27.92%. Specifically, large and mid-cap stocks such as DANGSUGAR, FIDELITYBK, ACCESSCORP, FLOURMILL, WAPCO, and GTCO enjoyed investors' patronage as their respective share prices inched higher by 7.95%, 2.14%, 1.85%, 1.03%, 0.37%, and 0.28%, respectively. Sectorial performance was strong, as the NGX Banking, NGX Insurance, NGX Consumer Goods, NGX Oil/Gas, and the NGX Industrial indexes advanced by 0.14%, 0.12%, 1.08%, 0.26%, and 0.02%, respectively. Meanwhile, market activity mellowed, with total deals, volume, and value decreasing by 5.73%, 39.94%, and 67.19%, respectively, amounting to 6,569 trades, 356.02 million units, and N4.23 billion. In terms of volume, TRANSCORP emerged as the most actively traded stock, with 76.72 million shares worth N442.06 million changing hands in 466 deals.





Money Market

NIBOR moderated across the board for most maturities tracked as gauges of money market stress eased, bolstered by FAAC inflows worth N966.11 billion. Notably, the three-month NIBOR rate decreased by 54 basis points, reaching 13.89%. The open repo rate (OPR) and the overnight lending rate (OVN) also declined, settling at 24.25% (from 24.50%) and 25.20% (from 25.40%), respectively. Furthermore, NITTY trended lower for all tracked tenor buckets amid renewed buying interest in short-term government securities. Likewise, the average secondary market yield on T-bill maturities closed lower at 8.19%.

Bond Market

In the OTC bond market, the values of FGN bonds were largely unchanged for most maturities tracked, as the average secondary market yield closed flat at 13.69%. Notably, the 30-year borrowing cost yielded around 15.45% (from 15.37%), while the 10-year and 20-year debts held steady at 14.34% and 15.19%, respectively.

Elsewhere, FGN Eurobonds saw depreciation across all tracked maturities, driving the average secondary market yield higher to 10.99%.

Foreign Exchange Market

In FX, the Naira weakened against the US dollar both at the official windows (trading at N778.42 from N771.69) and in the parallel market (depreciating by 1.10% to N915).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.97% to \$84.17 per barrel, while WTI crude gained 1.33% to \$80.10 per barrel.

Oil futures were higher on Friday but on course for weekly losses as a huge US crude inventory draw, limited downsides stemming from potential supply increases from Iran and Venezuela, as well as a slew of soft PMI data from advanced economies.

Elsewhere, gold was rangebound around \$1,918 per ounce (+0.04%) as traders positioned ahead of US Fed Reserve Chief Jerome Powell's speech at the Jackson Hole Symposium.
