





**Bearish Trend Sustains Momentum as the NGX ASI Sheds 80bps; NITTY Falls for All Maturities amid Sell Pressure...**

At the close of Tuesday's trading session, the domestic bourse index moderated by 0.80% to settle at 66,760.20 points amid sustained bearish activity even as the Exchange printed more bears (45) than bulls (16). Consequently, the year-to-date gain of the local bourse slipped to 30.26%. Specifically, tickers such as ETRANZACT, NASCON, DANGSUGAR, ACCESSCORP, ZENITHBANK, NESTLE, MTNN, and GTCO fell by 10.00%, 9.96%, 9.96%, 4.06%, 3.45%, 2.38%, 1.53%, and 1.41%, respectively, as investors booked profits. Sectorial performance was weak as three of the five indices tracked closed in the red zone: the NGX Banking, NGX Insurance, and NGX Consumer Goods indices fell by 2.60%, 2.31%, and 1.72%, respectively. On the other hand, the NGX Oil/Gas index closed flat, while the NGX Industrial index rose by 0.03%. Meanwhile, market activity improved further, with total deals, volume, and value increasing by 6.46%, 24.11%, and 32.16%, respectively, amounting to 10,554 trades, 645.54 million units, and N11.01 billion. TRANSCORP was the most actively traded stock, with 87.82 million shares worth N491.69 billion changing hands in 694 deals.



## Money Market

NIBOR rates moved in mixed directions for the maturities tracked. Notably, the three-month NIBOR rate fell by 6 basis points to 14.00% (from 14.06%). However, key money market rates such as the open repo rate (OPR) and the overnight lending rate (OVN) climbed further to 22.00% (from 22.11%) and 22.80% (from 20.83%), respectively, following funding pressure from yesterday's bond auctions.

Meanwhile, the Nigerian Interbank Treasury Bills True Yield (NITTY) observed an upward trend across all maturities, driven by profit-taking, which pushed yields higher. Likewise, the average secondary market yield on T-bills rose to 7.97%.

## Bond Market

In the OTC bond market, the values of FGN bonds were bearish across the majority of maturities tracked. Likewise, the average secondary market yield expanded to 13.87% (from 13.74%). Notably, the 10-year borrowing costs yielded around 14.61% (from 14.43%), while the 20-year and 30-year yields were approximately 15.49% (from 15.30%) and 15.81% (from 15.35%), respectively.

Elsewhere, FGN Eurobonds were bearish for all maturities tracked, with the average secondary market yield closing higher at 11.29%.

## Foreign Exchange Market

The Naira strengthened against the greenback, trading higher at N742.10 (from N773.50) at the Investors and Exporters (I&E) windows. However, the parallel market closed unchanged at N930.

## Global Commodity Market


At 3:30 p.m. GMT+1, Brent crude rose 1.63% to \$92.12 per barrel, while WTI crude gained 1.59% to \$88.68 per barrel.

Oil futures were up on Tuesday as traders digested an optimistic global energy demand projections by OPEC despite rising interest rates.

Gold prices, on the other hand, traded lower, with a 0.63% loss to \$1,909 per ounce, limited by an uptick in the US dollar ahead of Wednesday's US August CPI report.
