
**Strong Corporate Earnings Propel ASI to New High at 69,236.19 points; Money Market Rates Maintain Upward Trends on Liquidity Crunch....**

October closed in the green as bullish sentiment continues to pervade the equities market with the All-Share index advancing by 1.65% to close at a new high of 69,236.19 points after hitting a historic milestone of 69,264.12 points. This rally was buoyed by impressive earnings scorecards by corporates as well as announcement of corporate actions. Hence the year-to-date gain of the index rose to 35.09%, with 40 gainers outnumbering the 25 losers posted on Tuesday. Specifically, stocks such as AIRTELAFRI (+10%), CADBURY (+9.92%), NNFM (+9.92%), CHAMS (9.90%) and ABCTRANS (9.72%) were the toast of investors today. Across sub sector gauges, performance remained bullish as the Banking, Insurance and Industrial Goods sectors closed in the green zone increasing by 0.94%, 1.87%, and 0.09% respectively. While the Consumer Goods sector declined by 0.02%, the Oil/Gas sector remained unchanged from the previous day. Meanwhile, trading activity demonstrated further improvement with an uptick of 4.85% in total deals and 12.29% increase in volume, resulting to 8,027 trades and 483.27 million units; albeit, the total value plummeted by 26.80% to N6.04 billion. JAPPAULGOLD emerged as the most actively traded stock, with 155.59 million shares worth N181.86 million changing hands in 411 deals.



## Money Market

In the money market, NIBOR rose across the board for most maturities tracked indicating further liquidity strains in the financial system. Likewise, key money market rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), also increased to 15.58% and 16.46%

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) displayed upward movements for all tenors tracked. The average secondary market yield on Nigerian Treasury Bills closed flat at the end of Tuesdays' trading session.

## Bond Market

Within the secondary market for FGN Bonds, activity level was bearish at the close of Tuesdays' trading session as the average yield inched higher by 32bps to close at 15.33%. This was as a result of yield expansions in MAR 25 and JAN 26 FGN paper increasing to 2.18% and 1.13%.

In Nigeria's sovereign Eurobonds market, activity level was bullish leading to the average secondary market yield contracting by 39bps to close at 11.40%.

## Foreign Exchange Market

In the foreign exchange market, the Nigerian Naira traded positively against the US dollar. Specifically, the Naira appreciated by 17.96% to close at N815.32 to the dollar in the official I & E window. This comes even as the federal chart path to attaining stability of the local currency as well as improve the level of FX market liquidity. In a similar vein in the parallel market, the Naira's performance was positive as it appreciated further at the close of trading on Tuesday by 0.34%. The local currency closed at N1,176 per dollar from the previous sessions' N1,180 per dollar.
